A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the chapters of the
- 2 Hawaii Revised Statutes relating to mental health and
- 3 involuntary transport, examination, hospitalization, and
- 4 treatment have been amended in a piecemeal manner over the past
- 5 several decades. This has led to some lack in clarity and
- 6 inconsistencies. It is imperative that such an important part
- 7 of state law receives full and deliberate attention from time to
- 8 time to ensure the law's continued force and effectiveness.
- 9 The legislature further finds that a comprehensive review
- 10 of the Hawaii Penal Code has been conducted every decade since
- 11 the Code's enactment in 1972. The legislature believes that
- 12 periodically reviewing Hawaii's mental health laws would also be
- 13 helpful to advance the overall goal of improving mental health
- 14 in the State, especially for those unable to help themselves.
- 15 The purpose of this Act is to require the department of
- 16 health to convene an advisory committee on mental health code
- 17 review every ten years.

1 SECTION 2. Chapter 321, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§321-Advisory committee on mental health code review; report. (a) Beginning July 1, 2025, and every ten years 5 6 thereafter, the department of health shall convene an advisory 7 committee on mental health code review. The scope of the 8 advisory committee's review shall be determined by the 9 department of health; provided that every advisory committee 10 shall review all federal and state court cases and 11 constitutional, statutory, and rule changes impacting the Hawaii 12 Revised Statutes that relate to mental health and involuntary 13 transport, examination, hospitalization, and treatment, 14 including assisted community treatment, since the previous 15 advisory committee's review. 16 Membership of the advisory committee on mental health 17 code review shall be as follows: 18 The director of health, or the director's designee; (1)19 (2) The attorney general, or the attorney general's 20 designee;

1	<u>(3)</u>	A representative from the department of health, adult
2		mental health division, to be selected by the director
3		of health;
4	(4)	A representative from the department of corrections
5		and rehabilitation, to be selected by the director of
6		corrections and rehabilitation;
7	(5)	A representative of the judiciary, to be selected by
8		the chief justice;
9	(6)	A member of the senate standing committee with primary
10		subject matter jurisdiction over health or human
11		services, to be selected by the senate president;
12	(7)	A member of the house of representatives standing
13		committee with primary subject matter jurisdiction
14		over health or homelessness, to be selected by the
15		speaker of the house of representatives;
16	(8)	A representative from the prosecutor's office of each
17		county, to be selected by the respective prosecuting
18		attorney of each county;
19	<u>(9)</u>	A representative from the city and county of
20		Honolulu's crisis outreach response and engagement

1		program, to be selected by the mayor of the city and
2		county of Honolulu;
3	(10)	A representative from a private nonprofit human
4		services organization focused on ending or preventing
5		homelessness, to be selected by the director of
6		health;
7	(11)	Four members with relevant experience and expertise as
8		<u>a:</u>
9		(A) Psychologist or social worker;
10		(B) Psychiatrist;
11		(C) Representative from a residential treatment
12		program; or
13		(D) Representative from a mental health advocacy
14		group;
15		provided further that the president of the senate and
16		speaker of the house of representatives shall each
17		select two members; and
18	(12)	Any other representatives the advisory committee deems
19		necessary.
20	(c)	The members of the advisory committee on mental health
21	code revi	ew shall serve without compensation but shall be

I	reimbursed for expenses, including claver expenses, necessary
2	for the performance of their duties. The department of health
3	shall request the necessary funding for the advisory committee
4	to conduct its review during the regular session immediately
5	preceding the convening of the advisory committee.
6	(d) The advisory committee on mental health code review
7	shall submit a report of its findings and recommendations,
8	including any proposed legislation, to the legislature no later
9	than twenty days prior to the convening of the regular session
10	immediately following the convening of the advisory committee."
11	SECTION 3. New statutory material is underscored.
12	SECTION 4. This Act shall take effect upon its approval.
