A BILL FOR AN ACT

MAKING AN APPROPRIATION TO IMPLEMENT THE RECOMMENDATIONS OF THE TASK FORCE ON MOBILITY MANAGEMENT, ESTABLISHED PURSUANT TO ACT 214, SESSION LAWS OF HAWAII 2013.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 214, Session Laws of Hawaii 2013 (Act 214),
- 2 established a task force on mobility management within the
- 3 department of health. The task force was required to make
- 4 recommendations on establishing a transportation framework to
- 5 assist elders and individuals with disabilities with
- 6 transportation needs in each county, including recommendations
- 7 relating to the state budget and program development.
- 8 In enacting Act 214, the legislature found that Hawaii's
- 9 residents, including elders and individuals with disabilities,
- 10 should be able to live at home with the supports they need so
- 11 that they can participate in communities that value their
- 12 contributions. The legislature also found that statewide,
- 13 especially in rural communities, many residents are without
- 14 family members nearby to provide transportation and are too
- 15 frail or disabled to access public transit. Transportation
- 16 services are often fragmented, underutilized, or difficult to



- 1 navigate and can be costly because of inconsistent, duplicative,
- 2 and often restrictive federal and state program rules and
- 3 regulations. Due to these circumstances, there is a need for a
- 4 policy on mobility management, a concept in which a single
- 5 entity in a geographical area is charged with knowing and
- 6 deploying the entire array of transportation resources
- 7 available. This system would focus on the individual and
- 8 identify the best resources for that individual.
- 9 Act 214 required the department of health to submit interim
- 10 and final reports to the legislature of the task force's
- 11 findings and recommendations, including any proposed
- 12 legislation. The legislature finds that the task force's final
- 13 report, submitted to the legislature on January 30, 2015,
- 14 addressed the development and establishment of a mobility
- 15 management program and mobility center in a geographical area;
- 16 cost and qualifications of transportation/mobility coordinators
- 17 and logistics of developing a mobility center/program; and
- 18 development of a mobility management master plan for each county
- 19 and recommended that the State continue to support the counties'
- 20 efforts in developing their respective mobility management
- 21 program with the following suggested actions:

1	(\(\)	Fund local mobility projects identified by the county	
2		as priority strategies;	
3	(2)	Provide state leadership and coordination for the four	
4		counties to leverage federal funding;	
5	(3)	Establish a statewide purchasing cooperative among the	
6		counties and human service providers to procure new	
7		vehicles, technologies, and equipment; and	
8	(4)	Support a permanent funding source in any future state	
9		or local tax initiative for human service	
10		transportation.	
11	The	legislature further finds that there is still a strong	
12	need for m	mobility management in the State and it is critical	
13	that these	e recommendations are implemented.	
14	Acco	rdingly, the purpose of this Act is to appropriate	
15	funds to	the department of transportation to implement the	
16	recommendations of the task force on mobility management,		
17	established pursuant to Act 214, in consultation with the aging		
18	and disab	ility resource center of the executive office on aging	
19	and other stakeholder groups.		
20	SECT	ON 2. In accordance with section 9 of article VII of	
21	the Hawaii	State Constitution and sections 37-91 and 37-93,

- 1 Hawaii Revised Statutes, the legislature has determined that the
- 2 appropriations contained in Act 164, Regular Session of 2023,
- 3 and this Act will cause the state general fund expenditure
- 4 ceiling for fiscal year 2024-2025 to be exceeded by
- 5 \$ or per cent. This current declaration takes
- 6 into account general fund appropriations authorized for fiscal
- 7 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 8 only. The reasons for exceeding the general fund expenditure
- 9 ceiling are that:
- 10 (1) The appropriation made in this Act is necessary to
- serve the public interest; and
- 12 (2) The appropriation made in this Act meets the needs
- addressed by this Act.
- 14 SECTION 3. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2024-2025 for
- 17 the implementation of the recommendations made by the task force
- 18 on mobility management, established pursuant to Act 214, Session
- 19 Laws of Hawaii 2013, including funding for the establishment of
