# A BILL FOR AN ACT

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 149A-51, Hawaii Revised Statutes, is
amended to read as follows:

3 "**§149A-51** Advisory committee. (a) There shall be an 4 advisory committee on pesticides composed of but not limited to 5 the chairperson, or the chairperson's designated representative, who shall head the committee and one representative each from 6 7 the department of health, department of land and natural 8 resources, University of Hawaii college of tropical agriculture 9 and human resources, [sugar industry, pineapple industry,] 10 coffee industry, diversified agriculture industry, Hawaii Farm 11 Bureau [Federation], pesticide industry, structural pest control 12 industry, an environmental organization, a citizen group, and a 13 landscape professional.

14 (b) Members of the advisory committee shall be appointed 15 by the governor from a list of persons recommended by the 16 respective agencies and industries in accordance with section 17 26-34.
