A BILL FOR AN ACT

RELATING TO THE FUNDING OF GRANTS PURSUANT TO CHAPTER 42F, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I. GENERAL PROVISIONS 2 SECTION 1. SHORT TITLE. This Act shall be known and may 3 be cited as the Grant Funding Act of 2023. 4 SECTION 2. The grants made under this Act are made 5 pursuant to chapter 42F, Hawaii Revised Statutes. The 6 legislature finds that the grant recipients named in this Act 7 have applied for a grants pursuant to section 42F-102, Hawaii Revised Statutes, and qualify to receive a grant pursuant to 8 section 42F-103, Hawaii Revised Statutes. The appropriations 9 10 shall be disbursed by a contract between the named expending 11 agency and the grant recipient pursuant to sections 42F-104, 42F-105, and 42F-106, Hawaii Revised Statutes. Further, the 12 13 legislature finds and declares that the grants are in the public 14 interest and for the public health, safety, and general welfare 15 of the State.

provided that all appropriations made to be expended in fiscal
 biennium 2023-2025 that are unencumbered as of June 30, 2026,
 shall lapse as of that date.

SECTION 8. With the approval of the governor, designated expending agencies for capital improvement projects authorized in this Act may delegate to other state agencies the implementation of projects when it is determined advantageous to do so by both the original expending agency and the agency to which expending authority is to be delegated.

SECTION 9. Whenever the expending agency to which an appropriation is made is changed due to legislation enacted during any session of the legislature that affects the appropriations made by this Act, the governor shall transfer the necessary funds to the proper expending agency as provided by law.

PART V. MISCELLANEOUS AND EFFECTIVE DATE

17 SECTION 10. If any portion of this Act or its application 18 to any person, entity, or circumstance is held to be invalid for 19 any reason, the legislature declares that the remainder of the 20 Act and each and every other provision thereof shall not be 21 affected thereby. If any portion of a specific appropriation is

held to be invalid for any reason, the remaining portion shall
 be expended to fulfill the objective of that appropriation to
 the extent possible.

SECTION 11. If manifest clerical, typographical, or other
mechanical errors are found in this Act, the governor may
correct the errors.

7 SECTION 12. This Act shall take effect on June 30, 3000.
