## A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF EDUCATION FOR FOOD SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for 2 immediate passage in accordance with section 9 of article VII of 3 the Constitution of the State of Hawaii. SECTION 2. In accordance with section 9 of article VII of 4 the Constitution of the State of Hawaii and sections 37-91 and 5 6 37-93, Hawaii Revised Statutes, the legislature has determined that the general fund expenditure ceiling for fiscal year 2023-7 8 2024 has already been exceeded by \$ or per cent. 9 The appropriations contained in this Act will cause the state 10 general fund expenditure ceiling for fiscal year 2023-2024 to be 11 further exceeded by \$ or per cent. This declaration 12 takes into account the additional general fund appropriation 13 authorized for fiscal year 2023-2024 in this Act only. The 14 reasons for exceeding the general fund expenditure ceiling are 15 that: 16 (1) The appropriation made in this Act is necessary to 17 serve the public interest; and

- (2) The appropriation made in this Act meets the needs
  addressed by this Act.
- 3 SECTION 3. The department of education is required to
- 4 provide meal service for its students and staff. The department
- 5 provides about twenty thousand school breakfasts and eighty
- 6 thousand school lunches on a daily basis to students and staff
- 7 across the State.
- 8 The department of education has accumulated a deficit of
- 9 over \$20,000,000 for its food service operations. This is
- 10 largely due to inflationary cost increases. In school year 2022
- 11 to 2023, more than eighty per cent of the department's food
- 12 costs increased by forty-two per cent, resulting in the need for
- 13 additional funds.
- 14 For many students, a school meal is their only regular
- 15 source of food for their growing bodies and minds. School meals
- 16 must follow strict federal food safety and nutrition quidelines,
- 17 which ensures a quality meal. The department of education plays
- 18 a vital role in the health and well-being of youth in our
- 19 communities.
- 20 While students and staff must pay for their meals, Title I
- 21 students are provided meals free of charge. Also, because
- 22 feeding students is important for their development, students

2	contributed to this accumulated deficit.
3	The purpose of this Act is to make an emergency
4	appropriation to provide moneys for the department of education
5	to cover its food service fiscal deficit and to continue to
6	provide public school students with high-quality, nutritious
7	meals at an affordable price.
8	SECTION 4. There is appropriated out of the general
9	revenues of the State of Hawaii the sum of \$20,000,000 or so
10	much thereof as may be necessary for fiscal year 2023-2024 to
11	provide funding for the department of education to cover its
12	food service operations.
13	The sum appropriated shall be expended by the department of
14	education for the purposes of this Act.
15	SECTION 5. This Act shall take effect upon its approval.

TITLE: MAKING AN EMERGENCY APPROPRIATION TO THE

DEPARTMENT OF EDUCATION FOR FOOD SERVICES.

PURPOSE: To appropriate funds for the Department's

food service operations.

MEANS: Make an emergency appropriation of general

funds to the Department.

JUSTIFICATION: This emergency appropriation will provide

the Department with funding for its school

food service operations.

The Department is required to provide meal service for its students and staff. The Department provides about 20,000 school breakfasts and 80,000 school lunches on a daily basis to students and staff across the

State.

The Department has accumulated a deficit of over \$20 million dollars for its school food service operations. This is largely due to inflationary cost increases. In school year 2022 to 2023, more than eighty percent of the department's food costs increased by forty-two percent, resulting in the need for additional funds.

For many students, a school meal is their only regular source of food for their growing bodies and minds. School meals must follow strict federal food safety and nutrition guidelines, which ensures a quality meal. The Department plays a vital role in the health and well-being of youth in our community.

Impact on the public: The funding in this emergency appropriation will provide the resources needed to ensure continued school food operations, which feeds the students in our public schools. For many youth, school

food serves as their most nutritious and affordable meal of the day.

Impact on the department and other agencies: Serving school meals is a core function of the Department and is an expected service from the public. If the Department would no longer have the financial resources to serve student meals, it would severely impact the Department's ability to provide a quality

education for its students.
