A BILL FOR AN ACT

RELATING TO MANUFACTURED HEMP PRODUCTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 263, Session 2 Laws of Hawaii 2023, amended regulations on hemp production and 3 manufactured hemp products. However, the definition of 4 "manufactured hemp product" in section 328G-1, Hawaii Revised 5 Statutes, was inadvertently amended to be ambiguous and may be 6 read to limit the department of health's rulemaking authority to 7 regulate new types of hemp products as manufactured hemp 8 products.

9 The purpose of this Act is to clarify that the definition 10 of "manufactured hemp product" includes hemp products specified 11 in rules adopted by the department of health pursuant to section 12 328G-4, Hawaii Revised Statutes.

13 SECTION 2. Section 328G-1, Hawaii Revised Statutes, is 14 amended by amending the definition of "manufactured hemp 15 product" to read as follows:
