A BILL FOR AN ACT

RELATING TO DIRECT NEGOTIATION FOR PUBLIC LAND LEASES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the public auction process that is normally used to dispose of public land leases has become too protracted, cumbersome, and uncertain to the extent that it has deterred participation by potential lessees. The result is that properties have remained vacant, generating no income and serving no public benefit.

7 The legislature also finds that expediting the leasing
8 process would potentially make properties more attractive to
9 prospective lessees and result in the creation of a long-term
10 income stream.

11 The purpose of this Act is to expand the disposition of 12 public land leases through direct negotiation to include 13 commercial and industrial purposes.

SECTION 2. Section 171-59, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows:

16 "(b) Disposition of public lands for <u>uses related to</u> 17 airline, aircraft, <u>and airport-related[7] operations;</u>
