### A BILL FOR AN ACT

RELATING TO MEETING NOTICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 92-7, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) No less than six calendar days prior to the meeting,
4	the board shall post the notice on an electronic calendar on a
5	website maintained by the State or the appropriate county and
6	post a notice in the board's office for public inspection. The
7	notice shall also be posted at the site of the meeting whenever
8	feasible. The board shall file a copy of the notice with the
9	office of the lieutenant governor or the appropriate county
10	clerk's office and retain a copy of proof of filing the notice,
11	and the office of the lieutenant governor or the appropriate
12	clerk's office shall [timely post] ensure access to paper or
13	electronic copies of all meeting notices [in a central location
14	in a public building]; provided that a failure to do so by the
15	board, the office of the lieutenant governor, or the appropriate
16	county clerk's office shall not require cancellation of the
17	meeting. The copy of the notice to be provided to the office of
18	the lieutenant governor or the appropriate county clerk's office

1	may be provided via electronic mail to an electronic mail
2	address designated by the office of the lieutenant governor or
3	the appropriate county clerk's office, as applicable."

Mandates the Office of the Lieutenant Governor or the appropriate county clerk's office to ensure access to paper or electronic copies of all meeting notices and deletes the requirement to post notices in a central location in a public building.

### JUSTIFICATION SHEET SB. NO. 3171

DEPARTMENT: Lieutenant Governor.

TITLE: A BILL FOR AN ACT RELATING TO MEETING

NOTICES.

PURPOSE: To mandate the Office of the Lieutenant

Governor or the appropriate county clerk's

office to ensure access to paper or

electronic copies of all meeting notices and removes the requirement to post all meeting notices in a central location in a public

building.

MEANS: Amends section 92-7(b), Hawaii Revised

Statutes (HRS).

JUSTIFICATION: Hawaii is a state of islands with numerous

geographical barriers, and it is impractical for those who live on the neighbor islands to fly to Honolulu to view notices posted at

the State Capitol. Similarly, it is

impractical for those who live in Kona to drive to Hilo to view notices posted at the Hawaii County Office of the Clerk or for

those who live in Hana to drive to Wailuku to view notices posted at the Maui County

Office of the Clerk. Additionally, due to the COVID-19 pandemic and increased security

measures at the State Capitol and other government facilities, it is becoming increasingly challenging and unreasonable

for residents and interested parties to physically visit a government building to view posted notices. The amendments to

section 92-7(b), HRS, ensure that residents and interested parties have a variety of methods to view board notices and agendas: electronically available on an online

calendar, posted physically at the board's office and the site of the meeting when feasible, and via paper or electronic copy

by contacting the Office of the Lieutenant Governor or the appropriate county clerk's

office.

## SB. NO. 3171

Impact on the public: Increases the general public's access to board and commission meeting notices.

Impact on the department and other agencies:
Increases efficiency and decreases paper
usage for departments and agencies, which
currently must fax or physically drop-off
two printed notices at the Lieutenant
Governor's Office and frees the staff of the
Office of the Lieutenant Governor from
posting notices daily in the Chamber level
of the State Capitol.
