
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State has some 2 of the strongest gun safety laws in the nation, and in 2023 the 3 State received an A-minus rating from the Giffords Law Center to Prevent Gun Violence. Additionally, according to the Centers 4 5 for Disease Control and Prevention, the State had the third 6 lowest number of gun deaths per capita in the nation in 2021. 7 The legislature is committed to protect the safety and well-8 being of its citizens. However, the fact that Hawaii is the 9 only state with an assault weapons ban that fails to ban assault 10 rifles and assault shotquns is inconsistent with this 11 commitment.

12 Accordingly, the purpose of this Act is to:

13 (1) Amend the prohibition on certain assault weapons to
14 include assault rifles, assault shotguns, .50 caliber
15 rifles, and assault weapon attachments;

16 (2) Modernize the prohibition on assault pistols to
17 include pistols with one or more prohibited features;



1	(3)	Expand the ban on pistols with a detachable magazine	
2		with over a ten round capacity to any firearm with a	
3		detachable magazine with over a ten round capacity;	
4	(4)	Prohibit persons from bringing or causing to be	
5		brought into the State an assault rifle or assault	
6		shotgun;	
7	(5)	Prohibit the sale or transfer of an assault rifle or	
8		assault shotgun in the State, unless the assault rifle	
9		or assault shotgun is sold or transferred to an	
10		authorized individual; and	
11	(6)	Create exceptions for the acquisition and possession	
12		of prohibited firearms for members of law enforcement	
13		and the military.	
14	SECTION 2. Section 134-1, Hawaii Revised Statutes, is		
15	amended as follows:

19 (d) No person shall intentionally, knowingly, or20 recklessly lend a firearm to any person who is prohibited from





3 (e) After July 1, 1992, no person shall bring or cause to 4 be brought into the State an assault pistol. No assault pistol 5 may be sold or transferred on or after July 1, 1992, to anyone 6 within the State other than to a dealer licensed under section 7 134-32 or the chief of police of any county except that any 8 person who obtains title by bequest or intestate succession to 9 an assault pistol registered within the State shall, within 10 ninety days, render the weapon permanently inoperable, sell or transfer the weapon to a licensed dealer or the chief of police 11 12 of any county, or remove the weapon from the State.

13 (f) After July 8, 2024, except as provided by section 14 134-8(e), no person shall bring or cause to be brought into the 15 State an assault rifle, assault shotgun, .50 caliber rifle, or 16 assault weapon attachment. No assault rifle, assault shotgun, 17 .50 caliber rifle, or assault weapon attachment shall be sold or transferred on or after July 8, 2024, to anyone within the 18 19 State, other than to a dealer licensed under section 134-32 or 20 the chief of police of any county, except as provided by section 21 134-8(e); provided that any person who obtains title by bequest



1 or intestate succession to an assault rifle, assault shotgun, or 2 .50 caliber rifle registered within the State shall, within ninety days, render the weapon permanently inoperable, sell or 3 transfer the weapon to a licensed dealer of the chief of police 4 5 of any county, or remove the weapon from the State." 6 SECTION 4. Section 134-8, Hawaii Revised Statutes, is 7 amended to read as follows: 8 "§134-8 Ownership, etc., of automatic firearms, silencers, 9 etc., prohibited; penalties. 

14	begun before its effective date.
15	SECTION 7. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.

Firearms; Assault Rifles; Assault Shotguns; Assault Pistols; Assault Weapon Attachments; .50 Caliber Rifles; Magazine Capacity; Prohibition

Description:

Amends the prohibition on certain assault weapons to include assault rifles, assault shotguns, .50 caliber rifles, and assault weapon attachments. Modernizes the prohibition on assault pistols to include pistols with one or more prohibited feature. Expands the ban on pistols with a detachable magazine with over a ten round capacity to any firearm with a detachable magazine with over a ten round capacity. Prohibits persons from bringing or causing to be brought into the State an assault rifle or assault shotgun. Prohibits the sale or transfer of an assault rifle or assault shotgun in the State, unless the assault rifle or assault shotgun is sold or transferred to an authorized individual. Creates exceptions for the acquisition and possession of prohibited firearms for members of law enforcement and the military.
