### A BILL FOR AN ACT

RELATING TO RESILIENCE HUBS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a need for 2 resilience hubs in various communities to offer residents a place to obtain information, receive emergency supplies, store 3 4 and refrigerate medical supplies, receive basic medical care, charge electrical devices, and access the Internet during and 5 6 after a natural hazard event. The establishment of these 7 resilience hubs will likely require partnerships between 8 numerous agencies and private entities and the legislature finds 9 that the Hawaii emergency management agency is the most capable 10 agency to coordinate the establishment of resilience hubs.

11 The legislature further finds that resilience hub sites 12 should be carefully sited to ensure proper connection to the 13 electrical grid and be equipped with a solar and back-up battery 14 storage system to guard against power outages. Communities 15 should be directly involved in the siting and design of 16 resilience hubs in their community.

1	The legislature further finds that the establishment of		
2	resilience hubs will require dedicated funding and that there is		
3	a nexus between the need for resilience hubs and the use of		
4	petroleum and other fossil fuels. Therefore, it is appropriate		
5	to tax petroleum and other fossil fuel usage to fund resilience		
6	hubs.		
7	The purpose of this Act is to:		
8	(1) Establish the resilience hubs program within the		
9	Hawaii emergency management agency; and		
10	(2) Establish the resiliency hubs revolving fund to		
11	accomplish provisions of the resilience hubs program.		
12	SECTION 2. Chapter 127A, Hawaii Revised Statutes, is		
13	amended by adding two new sections to be appropriately		
14	designated and to read as follows:		
15	" <u>§127A-A</u> Resilience hubs program; established. (a) There		
16	is established the resilience hubs program within the Hawaii		
17	emergency management agency to set up resilience hubs in various		
18	communities to provide residents a place to obtain information,		
19	receive emergency supplies, store and refrigerate medical		
20	supplies, receive basic medical care, charge electrical devices,		
21	and access the Internet during and after a natural hazard event.

2	(1)	Identify possible site locations for the establishment
3		of resilience hub facilities;
4	(2)	Consult with the school of ocean and earth science and
5		technology at the university of Hawaii to identify
6		geographic areas where resilience hub sites would be
7		able to withstand natural disasters;
8	(3)	Negotiate and arrange for the purchase or lease of
9		suitable sites;
10	(4)	Contract for the design and construction of resilience
11		hub facilities; provided that if constructing on an
12		empty site, the program shall ensure that the
13		resilience hub facility is capable of withstanding
14		category four or category five hurricanes;
15	(5)	Install a solar and back-up battery storage system,
16		multiple electrical charging stations, internet
17		access, and refrigeration for medical supplies at each
18		resilience hub site;
19	(6)	Obtain suitable emergency supplies, including non-
20		perishable food, and equip each resilience hub site
21		with emergency supplies; and

1 SECTION 3. Section 243-3.5, Hawaii Revised Statutes, is 2 amended by amending its title and subsections (a) and (b) to 3 read as follows: 4 "§243-3.5 Environmental response, energy, [and] food 5 security, and resilience tax; uses. (a) In addition to any 6 other taxes provided by law, subject to the exemptions set forth 7 in section 243-7, there is hereby imposed a state environmental 8 response, energy, [and] food security, and resilience tax on 9 each barrel or fractional part of a barrel of petroleum product 10 sold by a distributor to any retail dealer or end user of 11 petroleum product, other than a refiner. The tax shall be \$1.05 on each barrel or fractional part of a barrel of petroleum 12 13 product that is not aviation fuel; provided that of the tax 14 collected pursuant to this subsection: 15 (1) 5 cents of the tax on each barrel shall be deposited 16 into the environmental response revolving fund 17 established under section 128D-2; 18 (2) 4 cents of the tax on each barrel shall be deposited 19 into the energy security special fund established 20 under section 201-12.8;
