A BILL FOR AN ACT

RELATING TO VETERINARIANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a need for
- 2 more licensed veterinarians in the State. Specifically, as of
- 3 2020, only about three hundred twenty veterinarians were working
- 4 in Hawaii. This number is expected to grow by only about 1.6
- 5 per cent each year through 2030, which is not enough to meet the
- 6 State's growing demand for veterinarians.
- 7 The legislature further finds that there are a number of
- 8 issues that limit the potential to increase the number of
- 9 licensed veterinarians in the State. First, there is currently
- 10 no in-state veterinary school. Therefore, residents who wish to
- 11 pursue careers as veterinarians must leave the State to obtain
- 12 the necessary education and training. In addition, students
- 13 wishing to attend a public veterinary school will likely need to
- 14 pay tuition at the rate applicable to out-of-state students.
- 15 Accordingly, the cost to obtain a veterinary education may
- 16 exceed \$250,000. Although there are likely many residents who
- 17 aspire to become licensed veterinarians, these factors make this



- 1 goal too expensive for many to attain. Finally, Hawaii's high
- 2 cost of living may deter some veterinarians from opening
- 3 practices in the State. In light of these foregoing issues, the
- 4 legislature finds that steps must be taken to incentivize
- 5 veterinarians to practice in Hawaii.
- 6 The legislature further finds that the John A. Burns School
- 7 of Medicine administers a state loan repayment and scholarship
- 8 program that provides loan repayments to physicians who commit
- 9 to working in certain parts of the State, and awards
- 10 scholarships to qualifying medical students. This program has
- 11 successfully incentivized more physicians to remain in Hawaii to
- 12 practice medicine. The legislature finds that expanding this
- 13 program to include scholarships and loan repayments for current
- 14 and future veterinarians is a potential way to grow that
- 15 profession in Hawaii.
- Accordingly, the purpose of this Act is to expand the
- 17 current state loan repayment and scholarship program for
- 18 physicians to include veterinarians by:
- 19 (1) Renaming the John A. Burns school of medicine special
- fund as the physician and veterinarian special fund;

- 19 SECTION 5. In accordance with section 9 of article VII, of 20 the Constitution of the State of Hawaii and sections 37-91 and
- 21 37-93, Hawaii Revised Statutes, the legislature has determined

- 1 that the appropriation contained in this Act will cause the
- 2 state general fund expenditure ceiling for fiscal year 2024-2025
- 3 to be exceeded by \$, or per cent. The
- 4 reasons for exceeding the general fund expenditure ceiling are
- 5 that the appropriation made in this Act is necessary to serve
- 6 the public interest and to meet the need provided for by this
- 7 Act.
- 8 SECTION 6. There is appropriated out of the general
- 10 much thereof as may be necessary for fiscal year 2024-2025 to be
- 11 deposited into the physician and veterinarian special fund.
- 12 SECTION 7. There is appropriated out of the physician and
- 13 veterinarian special fund the sum of \$ or so much
- 14 thereof as may be necessary for fiscal year 2024-2025 to provide
- 15 loan repayments and scholarships to persons who commit to
- 16 working as veterinarians in the State.
- 17 The sum appropriated shall be expended by the board of
- 18 veterinary medicine for the purposes of this Act.
- 19 SECTION 8. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.

1 SECTION 9. This Act shall take effect on July 1, 2024.

Report Title:

Veterinarians; Hawaii Board of Veterinary Medicine; Scholarships; Loan Repayment; John A. Burns School of Medicine Special Fund; General Fund Expenditure Ceiling Exceeded; Appropriation

Description:

Renames the John A. Burns School of Medicine special fund as the physician and veterinarian special fund. Expands the authorized uses of the special fund to include providing loan repayments to veterinarians and scholarships for students attending a veterinary college; provided that the recipient commits to work in the State for a period of time determined by the Hawaii Board of Veterinary Medicine. Requires the Hawaii Board of Veterinary Medicine to establish a loan repayment and scholarship program. Assesses a fee on persons obtaining or renewing a veterinarian license. Provides for the deposit of the fee into the physician and veterinarian special fund. Appropriates moneys into and out of the physician and veterinarian special fund. Declares that the appropriation exceeds the state general fund expenditure ceiling.
