# A BILL FOR AN ACT

RELATING TO VEGETATION MANAGEMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to appropriate funds
- 2 to the department of transportation and department of land and
- 3 natural resources division of forestry and wildlife for the
- 4 purpose of promoting vegetation management to reduce the risks
- 5 of wildfires across the State.
- 6 SECTION 2. In accordance with section 9 of article VII of
- 7 the Hawaii State Constitution and sections 37-91 and 37-93,
- 8 Hawaii Revised Statutes, the legislature has determined that the
- 9 appropriations contained in Act 164, Regular Session of 2023,
- 10 and this Act will cause the state general fund expenditure
- 11 ceiling for fiscal year 2024-2025 to be exceeded by
- 12 \$ or per cent. This current declaration takes
- 13 into account general fund appropriations authorized for fiscal
- 14 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 15 only. The reasons for exceeding the general fund expenditure
- 16 ceiling are that:

- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$5,000,000 or so much
- 7 thereof as may be necessary for fiscal year 2024-2025 to the
- 8 department of transportation for vegetation management projects
- 9 to reduce the risks of wildfires across the State.
- 10 The sum appropriated shall be expended by the department of
- 11 transportation for the purposes of this Act.
- 12 SECTION 4. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$5,000,000 or so much
- 14 thereof as may be necessary for fiscal year 2024-2025 to the
- 15 division of forestry and wildlife for vegetation management
- 16 projects to reduce the risks of wildfires across the State.
- 17 The sum appropriated shall be expended by the Department of
- 18 Land and Natural Resources for the purposes of this Act.
- 19 SECTION 5. This Act shall take effect on July 1, 2024.
