A BILL FOR AN ACT

RELATING TO LABELING OF MACADAMIA NUTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 486-120.5, Hawaii Revised Statutes, is	
2	amended to read as follows:		
3	"§486	5-120.5 Macadamia nuts; labeling requirements. (a)	
4	If a label	on a consumer package contains language that all of	
5	the raw or	processed macadamia nuts contained in the package	
6	were grown	n in Hawaii, the label shall be worded, "100% Hawaii-	
7	Grown Maca	adamia Nuts", "Hawaii-Grown Macadamia Nuts", "100%	
8	Hawaiian N	Macadamia Nuts", or "Hawaiian Macadamia Nuts", and	
9	shall appe	ear on the principal display panel of the package.	
10	(b)	If a label on a consumer package [contains]:	
11	(1)	Contains language that a portion of the raw or	
12		processed macadamia nuts contained in the package was	
13		grown in Hawaii[-]; or	
14	(2)	By any other means, including but not limited to a	
15		company name or the use of images of the State,	
16		represents the origin of the raw or processed	

1	macadamia nuts as being from any place within the
2	State,
3	the label shall be worded "Hawaii-Grown Macadamia Nuts",
4	preceded by the per cent by weight of the macadamia nuts
5	contained in the package that were grown in Hawaii, and shall
6	appear on the principal display panel of the package. The per
7	cent by weight of the macadamia nuts in the package shall be th
8	percentage calculated by dividing the weight in pounds of the
9	macadamia nuts grown in Hawaii that are in the package by the
10	weight in pounds of all macadamia nuts in the package and
11	multiplying the quotient by one hundred. A listing of the
12	countries of origin of the portion of the raw or processed
13	macadamia nuts not grown in Hawaii that are included in the
14	package shall also be shown on the label.
15	(c) All nonconsumer packages containing macadamia nuts
16	grown in the State and introduced into intrastate or interstate
17	commerce shall bear on the package a label containing language
18	that the package contains Hawaii-grown macadamia nuts. This
19	label shall be in addition to all other labeling requirements
20	specified in this chapter.

•	(4)	any person keeping, oriening, dispidying, exposing for
2	sale, or	soliciting for sale, any raw or processed macadamia nut
3	product,	which represents or which is branded or labeled that
4	all or a	percentage or portion of the macadamia nuts were grown
5	in Hawaii	, shall make available to the administrator, upon
6	demand, d	ocumented proof that the amount of macadamia nuts
7	represent	ed to be grown in the State, was grown in the State.
8	(e)	It shall be a violation of this part:
9	(1)	To use a label containing the words, "100% Hawaii-
10		Grown Macadamia Nuts", "Hawaii-Grown Macadamia Nuts",
11		"100% Hawaiian Macadamia Nuts", or "Hawaiian Macadamia
12		Nuts", or similar wording, or to otherwise represent
13		that all of the macadamia nuts in the package were
14		grown in Hawaii, if any portion of the macadamia nuts
15		contained in the package was not grown in the State;
16	(2)	To use a label, as provided for under subsection (b),
17		containing the words "Hawaii-Grown Macadamia Nuts"
18		preceded by a percentage, if less than the specified
19		percentage or none of the macadamia nuts in the
20		package was grown in the State; [or]

1	(3)	To use a label, as provided for under subsection (b),
2		containing the words "Hawaii-Grown Macadamia Nuts"
3		that misrepresents the origin of the macadamia nuts in
4		the package as being grown in the State, including but
5		not limited to the use of a company name or the use of
6		images of the State, if less than the specified
7		percentage or none of the macadamia nuts in the
8		package were grown in the State; or
9	[(3)]	(4) To use a label representing that any of the
10		macadamia nuts contained in the package was grown in
11		the State, if none of the macadamia nuts contained in
12		the package was grown in the State.
13	(f)	Any person who violates this section shall be subject
14	to penalt	ies under section 486-32.
15	(g)	Any person injured by a violation of this section may
16	bring a c	ivil action in court for damages."
17	SECT	ION 2. Statutory material to be repealed is bracketed
18	and stric	ken. New statutory material is underscored.
19	SECT	ION 3. This Act shall take effect upon its approval.
