A BILL FOR AN ACT

RELATING TO STATE HOLIDAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, on January 17,
- 2 1893, the Kingdom of Hawaii witnessed the unjust and illegal
- 3 overthrow of its sovereign monarch, Queen Liliuokalani,
- 4 resulting in the disruption of the Hawaiian government and the
- 5 sovereignty of the Hawaiian people. The actions that led to the
- 6 overthrow of Queen Liliuokalani and the Kingdom of Hawaii were
- 7 inconsistent with the principles of justice, self-determination,
- 8 and international law.
- 9 In 1993, the United States Congress, through P.L. 103-150,
- 10 formally acknowledged the role of the United States in the
- 11 illegal overthrow of the Kingdom of Hawaii and expressed regret
- 12 for the wrongful actions committed. In addition, P.L. 103-150
- 13 recognized and supported the reconciliation efforts that were
- 14 initiated between the United States, the State, the United
- 15 Church of Christ, and the Native Hawaiian people.
- 16 The legislature finds that, in the spirit of advancing
- 17 those initial efforts made towards reconciliation, it is

- 1 imperative to recognize and remember this historical injustice,
- 2 to ensure that future generations are aware of the devastating
- 3 negative impact of the events of January 17, 1893, on the
- 4 Hawaiian people and their culture.
- 5 Accordingly, the purpose of this Act is to:
- 6 (1) Designate the seventeenth day in January of each year
- 7 as Reconciliation Day, to commemorate the memory of
- 8 Queen Liliuokalani and the illegal overthrow of the
- 9 Kingdom of Hawaii;
- 10 (2) Establish Reconciliation Day as a state holiday;
- 11 (3) Require the State and its departments and agencies to
- recognize Reconciliation Day through educational
- programs, cultural events, and activities;
- 14 (4) Require the governor to issue an annual proclamation
- recognizing Reconciliation Day as a day of reflection
- and remembrance;
- 17 (5) Require all state offices, public schools, and other
- state institutions to display the Hawaiian flag at
- half-staff on Reconciliation Day; and
- 20 (6) Repeal Good Friday as a state holiday.

- 1 All election days, except primary and special election
- 2 days, in the county wherein the election is held; and
- 3 Any day designated by proclamation by the President of the
- 4 United States or by the governor as a holiday."
- 5 SECTION 3. The State and its departments and agencies
- 6 shall recognize Reconciliation Day through educational programs,
- 7 cultural events, and activities that promote awareness and
- 8 understanding of the historical significance of January 17,
- 9 1893.
- 10 SECTION 4. The governor shall issue an annual proclamation
- 11 recognizing Reconciliation Day as a day of reflection and
- 12 remembrance, and encourage citizens to learn about and
- 13 understand the history surrounding the overthrow of Queen
- 14 Liliuokalani and the consequences of the continued illegal
- 15 occupation of Hawaii.
- 16 SECTION 5. All state offices, public schools, and other
- 17 state institutions shall display the Hawaiian flag at half-staff
- 18 on Reconciliation Day, to honor the memory of Queen Liliuokalani
- 19 and the legacy of Hawaiian oppression, dispossession, and
- 20 diaspora which resulted from her illegal overthrow.

- 1 SECTION 6. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 7. This Act shall take effect upon its approval.

Report Title:

Governor; State Departments and Agencies; Schools; Public Administration; State Holidays; Reconciliation Day

Description:

Designates the seventeenth day in January of each year as Reconciliation Day. Establishes Reconciliation Day as a state holiday. Requires the State and its departments and agencies to recognize Reconciliation Day through educational programs, cultural events, and activities. Requires the Governor to issue an annual proclamation recognizing Reconciliation Day as a day of reflection and remembrance. Requires all state offices, public schools, and other state institutions to display the Hawaiian flag at half-staff on Reconciliation Day. Repeals Good Friday as a state holiday.
