A BILL FOR AN ACT

RELATING TO CHILD WELFARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

l	SECT.	ION 1. The purpose of this Act is to:
2	(1)	Expand the investigative powers of the department of
3		human services to include review and investigation of
4		families that receive benefits from the State's
5		adoption assistance program and against whom a
6		post-adoption complaint has been made;
7	(2)	Require the department of human services to report to
8		the legislature before the convening of the regular
9		session of 2025 on the impact of expanding
10		post-permanency services to families receiving
11		benefits from the adoption assistance program;
12	(3)	Require the department of human services to establish
13		a working group to seek, design, and recommend
14		transformative changes to the State's existing child
15		welfare system; and

1	(4) Appropriate funds to increase the procurement of
2	contracted services to provide additional support,
3	resources, and monitoring of post-permanency services.
4	SECTION 2. Section 346-301, Hawaii Revised Statutes, is
5	amended to read as follows:
6	"[+]§346-301[+] Adoption assistance program
7	established[.]; review or investigation of program benefit
8	recipients. The department of human services shall maintain an
9	adoption assistance program to facilitate the adoption of
10	children with special needs. Families receiving benefits from
11	the adoption assistance program and against whom a post-adoption
12	complaint has been made with the department of human services
13	shall be subject to review or investigation in a manner, place,
14	and form as may be prescribed by the department or its
15	authorized agents in accordance with chapters 350 and 587A."
16	SECTION 3. The department of human services shall collect
17	and analyze data to determine the impact of expanding
18	post-permanency services to families receiving benefits from the
19	adoption assistance program and shall submit a report of its
20	findings and recommendations, including any proposed

2	to the co	nvening of the regular session of 2025.
3	SECT	ION 4. (a) There is established within the department
4	of human	services, a Malama Ohana working group to consider,
5	develop,	and recommend transformative changes to the State's
6	existing	child welfare system.
7	(b)	The Malama Ohana working group shall consist of the
8	following	members:
9	(1)	The executive director of Effective Planning and
10		Innovative Communication, Inc., doing business as EPIC
11		Ohana, or the executive director's designee, who shall
12		serve as a co-chair of the working group;
13	(2)	The chief executive officer of Hale Kipa, Inc., or the
14		chief executive officer's designee, who shall serve as
15		a co-chair of the working group;
16	(3)	Four members of Na Kama a Haloa;
17	(4)	Two members from each of the following constituencies,
18		selected by the board of directors of Epic Ohana, Inc.
19		that operates the Na Kama a Haloa program:

(A) Former foster youth;

2		welfare system, specifically, with the departmen
3		of human services' child welfare service branch;
4		(C) Licensed resource caregivers; and
5		(D) Kinship resource caregivers;
6	(5)	The director of human services or the director's
7		designee;
8	(6)	Two members representing the child welfare services
9		branch's investigators, case managers, or their
10		assistants, designated by the branch administrator;
11	(7)	The chairperson of the trauma-informed care task
12		force, or the chairperson's designee;
13	(8)	The chief executive officer of the office of Hawaiian
14		affairs, or the chief executive officer's designee;
15	(9)	The chief executive officer of Kamehameha Schools, or
16		the chief executive officer's designee; and
17	(10)	The chief executive officer of Liliuokalani Trust, or
18		the chief executive officer's designee.
19	(c)	The Malama Ohana working group shall develop
20	recommend	ations to establish a child welfare system that is
21	trauma in	formed, sustains a community-based partnership, and is

1	responsive	e to the needs of children and families in the system
2	as well as	s the community. In carrying out its purpose, the
3	working g	roup shall:
4	(1)	Conduct listening sessions throughout the State and
5		with affected constituencies;
6	(2)	Convene meetings to brainstorm and develop concepts
7		for recommendation;
8	(3)	Develop recommendations on ways to better coordinate
9		and improve the protection and well-being of children
10		and families in the child welfare system;
11	(4)	Identify training, best practices, assessment
12		criteria, and ways to sustain an effective workforce
13		within the department of human services' child welfare
14		services branch;
15	(5)	Identify training, best practices, assessment
16		criteria, and ways to sustain an effective workforce
17		within the community of agencies serving the child
18		welfare system;
19	(6)	Identify best practices, including Native Hawaiian
20		cultural practices, that provide assistance to

1		children and youth who are involved in the child
2		welfare system and their families;
3	(7)	Identify other cultural practices that build wellness
4		and resilience in communities and collaboration
5		between communities and the child welfare services
6		branch; and
7	(8)	Collaborate with the trauma-informed care task force,
8		and where appropriate, conduct joint listening
9		sessions or design sessions for the purpose of
10		reforming the child welfare system.
11	(d)	Members of the Malama Ohana working group shall serve
12	without co	ompensation but shall be reimbursed for reasonable
13	expenses	necessary for the performance of their duties,
14	including	travel expenses. No member of the working group shall
15	be subject	t to chapter 84, Hawaii Revised Statutes, solely
16	because o	f the member's participation in the working group.
17	(e)	The department of human services may contract with an
18	administra	ative facilitator to provide necessary support for the
19	Malama Oha	ana working group in carrying out its activities,
20	including	preparation of the report required pursuant to
21	subsection	n (f).

5		working group established within the department of
6		human services pursuant to section 4 of this Act, to
7		contract with an administrative facilitator to provide
8		necessary support for the working group in carrying
9		out its activities.

12	SECT	ION 7. This Act shall take effect upon its approval;
13	provided	that section 5 of this Act shall take effect on July 1,
14	2023, and	section 4 of this Act shall be repealed on June 30,
15	2025.

Report Title:

Department of Human Services; Foster Care; Adoption; Adoption Assistance Program; Review; Investigation; Malama Ohana Working Group; Post-Permanency Services; Report; Appropriation

Description:

Expands the investigative powers of the Department of Human Services to include review and investigation of families that receive benefits from the State's adoption assistance program, against whom a post-adoption complaint has been made. Requires the Department of Human Services to report to the Legislature prior to the convening of the 2025 Regular Session on the impact of expanding post-permanency services to families receiving benefits from the adoption assistance program. Establishes a working group within the Department of Human Services to consider, develop, and recommend transformative changes to the State's existing child welfare system, and report to the Legislature prior to the 2025 Regular Session. Appropriates funds to provide additional support, resources, and monitoring of post-permanency services. Repeals the Malama Ohana Working Group on 6/30/2025.
