A BILL FOR AN ACT

RELATING TO STATE WATER CODE PENALTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in 1987, the State 2 Water Code was adopted to protect the precious water resources 3 of the State. To better enable the department of land and 4 natural resources and commission on water resource management to 5 carry out that mission, the legislature further finds that the water code's penalties and fines must be amended and increased 6 7 to serve as an effective deterrence to violators. 8 The purpose of this Act is to ensure that all violators of 9 the State Water Code are held accountable for their violations 10 by: 11 (1) Creating a minimum penalty of \$50 for every violation 12 of the State Water Code; (2) Raising the maximum penalty to \$60,000 for every 13 violation of the State Water Code; 14 (3) Clarifying that each day that a violation exists or 15 16 continues to exist is a separate offense;

- 2 violation exists or continues to exist shall constitute a
- 3 separate offense. Penalties for continuing violations shall be
- 4 assessed from the earliest known date of the violation. The
- 5 earliest known date of a violation shall be determined by the
- 6 commission by a preponderance of the evidence; provided that if
- 7 the earliest known date cannot be determined by a preponderance
- 8 of the evidence, penalties for continuing violations shall be
- 9 assessed from the earliest date the commission is made aware of
- 10 the violation.
- 11 (c) The commission shall determine the penalty amount for
- 12 each violation after reviewing the circumstances of the
- 13 violation; taking into account the nature, extent, and gravity
- 14 of the violation; and considering the history of such
- 15 violations, degree of culpability, and other matters as justice
- 16 may require.
- 17 [(c)] (d) No provision of this chapter shall bar the right
- 18 of any injured person to seek other legal or equitable relief
- 19 against a violator of this chapter.

20	management to enforce compliance with the State Water Code.

- 5 SECTION 5. This Act shall take effect on June 30, 3000.

Description:

Creates a minimum penalty and raises the maximum penalty for every violation of the State Water Code. Clarifies that each day a violation exists or continues is a separate offense. Requires the Commission on Water Resource Management to determine the amount of the penalty based on the circumstances of the violation. Appropriates funds for positions in the Commission on Water Resource Management. Effective 6/30/3000. (HD2)
