A BILL FOR AN ACT

RELATING TO GASOLINE-POWERED LEAF BLOWERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that dozens of cities and
- 2 towns in the United States and the District of Columbia and
- 3 State of California have banned gasoline-powered leaf blowers
- 4 due to their harmful impacts on health and the environment.
- 5 The legislature also finds that noise can be a pollutant
- 6 that affects the public health. Noise causes hearing loss;
- 7 interferes with human activities at home, work, and in schools;
- 8 and is injurious to people's health and well-being in various
- 9 ways. Noise annoys, awakens, angers, and frustrates people.
- 10 The numerous effects of noise combine to detract from the
- 11 quality of life for people and the environment.
- 12 The sound emissions from gasoline-powered leaf blowers are
- 13 a public nuisance and a great concern for the State's public
- 14 health and welfare. Gasoline-powered leaf blowers operate at
- 15 approximately ninety decibels, which can cause hearing damage
- 16 after two hours of exposure. According to the United States

- 1 Centers for Disease Control and Prevention, noise intensity is a
- 2 particularly troubling issue for landscaping workers.
- 3 The legislature further finds that there are viable,
- 4 quieter alternatives to gasoline-powered leaf blowers such as
- 5 battery-powered leaf blowers.
- 6 Accordingly, the purpose of this Act is to ban the use of
- 7 gasoline-powered leaf blowers in any urban land use district.
- 8 SECTION 2. Section 342F-30.8, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- "[+] §342F-30.8[+] Leaf blowers; restrictions[-] on non-
- 11 gasoline-powered leaf blowers; prohibition of gasoline-powered
- 12 leaf blowers. (a) In any urban land use district, as
- 13 designated pursuant to section 205-2, it shall be unlawful for
- 14 any person to operate a non-gasoline-powered leaf blower within
- 15 a residential zone or within one hundred feet of a residential
- 16 zone in the State, except between the hours of 8:00 a.m. and
- 17 6:00 p.m. on any day except Sunday or a state or federal
- 18 holiday, and between the hours of 9:00 a.m. and 6:00 p.m. on
- 19 Sunday or any state or federal holiday.

1	(b) In any urban land use district, as designated pursuant
2	to section 205-2, it shall be unlawful for any person to operate
3	a gasoline-powered leaf blower at any time.
4	$[\frac{(b)}{(c)}]$ Violators shall be fined $[\frac{$50}{]}$ $\frac{$100}{}$ for the
5	first violation, $[\$100]$ $\$250$ for the second violation, $[\$200]$ for
6	the third violation, and \$500 for each subsequent violation [-];
7	provided that upon the third violation of subsection (b), the
8	gasoline-powered leaf blower used to commit that violation shall
9	be subject to forfeiture.
10	[(c) Government entities, and agents acting on behalf of
11	government entities, shall not be subject to this section.
. 12	(d) Any county may adopt a rule or ordinance that places
13	stricter limitations on the use of leaf blowers than are in this
14	section. In case of a conflict between the requirements or
15	limitations of this section and any county rule or ordinance
16	regarding the use of leaf blowers, the more restrictive
17	requirements shall apply.
18	(e) For the purposes of this section:
19	"Gasoline-powered leaf blower" means any leaf blower that

is powered by a two-stroke internal combustion engine that is

- 1 rated for noise emissions of greater than sixty-five decibels at
- 2 a distance of fifty feet.
- 3 "Leaf blower" means any machine used to blow leaves, dirt,
- 4 or other debris off sidewalks, driveways, lawns, and other
- 5 surfaces.
- 6 "State holiday" means any day established as a state
- 7 holiday in section 8-1."
- 8 SECTION 3. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 4. If any provision of this Act, or the
- 12 application thereof to any person or circumstance, is held
- 13 invalid, the invalidity does not affect other provisions or
- 14 applications of the Act that can be given effect without the
- 15 invalid provision or application, and to this end the provisions
- 16 of this Act are severable.
- 17 SECTION 5. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 6. This Act shall take effect on June 30, 3000.

Gasoline-Powered Leaf Blowers; Prohibition; Fines; Government Agency Exemption; Repeal

Description:

Prohibits the operation of gasoline-powered leaf blowers in any urban land use districts. Increases the amounts of fines for violations of leaf blower restrictions and provides for the forfeiture of gasoline-powered leaf blowers upon a third violation. Removes the exemption on leaf blower restrictions for government agencies and their agents. Effective 6/30/3000. (HD1)
