### A BILL FOR AN ACT

RELATING TO CONDOMINIUMS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 514B-107, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§514B-107 Board; limitations. (a) Members of the board
- 4 shall be unit owners or co-owners, vendees under an agreement of
- 5 sale, a trustee of a trust which owns a unit, or an officer,
- 6 partner, member, or other person authorized to act on behalf of
- 7 any other legal entity which owns a unit. There shall not be
- 8 more than one representative on the board from any one unit.
- 9 (b) No tenant, resident manager, or employee of a
- 10 condominium shall serve on its board.
- 11 For the purposes of this subsection, "tenant" means any
- 12 person who occupies a dwelling unit for dwelling purposes who is
- 13 not also an owner of a dwelling unit in the same condominium.
- (c) An owner shall not act as an officer of an association
- 15 and an employee of the managing agent retained by the
- 16 association. Any owner who is a board member of an association
- 17 and an employee of the managing agent retained by the

- 1 association shall not participate in any discussion regarding a
- 2 management contract at a board meeting and shall be excluded
- 3 from any executive session of the board where the management
- 4 contract or the property manager will be discussed.
- 5 (d) Directors shall not expend association funds for their
- 6 travel, directors' fees, and per diem, unless owners are
- 7 informed and a majority approve of these expenses; provided
- 8 that, with the approval of the board, directors may be
- 9 reimbursed for actual expenditures incurred on behalf of the
- 10 association. The board meeting minutes shall reflect in detail
- 11 the items and amounts of the reimbursements.
- 12 (e) Associations at their own expense shall provide all
- 13 board members with a current copy of the association's
- 14 declaration, bylaws, house rules, and, annually, a copy of this
- 15 chapter with amendments.
- 16 (f) The directors may expend association funds, which
- 17 shall not be deemed to be compensation to the directors, to
- 18 educate and train themselves in subject areas directly related
- 19 to their duties and responsibilities as directors; provided that
- 20 the approved annual operating budget shall include these
- 21 expenses as separate line items. These expenses may include

- 1 registration fees, books, videos, tapes, other educational
- 2 materials, and economy travel expenses. Except for economy
- 3 travel expenses within the State, all other travel expenses
- 4 incurred under this subsection shall be subject to the
- 5 requirements of subsection (d).
- 6 (g) The board shall not expend association funds in an
- 7 amount of \$10,000 or greater without first obtaining approval by
- 8 the association in accordance with the voting percentages
- 9 established in this chapter."
- 10 SECTION 2. New statutory material is underscored.
- 11 SECTION 3. This Act shall take effect upon its approval.
