RELATING TO NOISE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that noise pollution is a
public health hazard that continues to affect Hawaii residents.
The most common health problems caused by noise pollution are
noise-induced hearing loss, high blood pressure, heart disease,
sleep disturbances, and stress.

6 The legislature further finds that the community noise code 7 adopted by the department of health as title II Hawaii 8 Administrative Rules chapter 46, is more than twenty-six years 9 old and may not adequately reflect the higher levels of noise 10 pollution as residential and urban zoning districts have 11 changed.

12 The purpose of this Act is to require the department of 13 health to update the state community noise code to address noise 14 concerns that were not included in the adoption of rules in 15 1996.

16 SECTION 2. Section 342F-30.5, Hawaii Revised Statutes, is 17 amended to read as follows:

16	SECTION 3. Statutory material to be repealed is bracketed	
17	and stricken. New statutory material is underscored.	
18	SECTION 4. This Act shall take effect upon its approval.
