# S.B. NO. 615

### Report Title:

Education; Public Schools; Public Charter Schools; Epinephrine; Appropriation

### Description:

Requires each public or public charter school to have staff trained in the administration of, and authorized to administer, epinephrine. Requires signs to be displayed in school buildings stating the symptoms of anaphylaxis and the proper method for administering epinephrine. Appropriates moneys.
