The legislature finds that in rural areas such

RELATING TO ENVIRONMENTAL INVESTIGATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2 as Molokai, a remote island with a population of about seven 3 thousand people, many state departments do not staff full-time employees dedicated to enforcement activities. Therefore, when 4 5 a complaint is made, department staff members are not physically 6 present to address the situation; instead, state departments 7 rely on still photos and videos that may not capture the full 8 extent of the situation or be sufficient to support the issuance 9 of a citation. State departments must then determine whether to 10 send a staff member into the field after the fact to 11 investigate, which can take weeks to schedule depending upon 12 flight schedules or staff availability. The delay hinders the 13 ability of any government inspector to witness the violation and

issue an enforceable citation. These limitations lead to delays

in stopping environmentally hazardous activities that impact the

health and safety of the residents of Molokai.
