A BILL FOR AN ACT

RELATING TO ACUPUNCTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the regulation of
2	medical professionals is important to ensure public safety and
3	promote access to quality care. Acupuncture is one of the
4	fastest growing fields in American health care due to expanded
5	benefits under health insurance policies and medicare and is a
6	popular treatment among patients seeking an alternative to
7	prescription opioids and those with other medical conditions.
8	The legislature further finds that many existing state laws
9	regarding acupuncturists have not been updated in over twenty
10	years, despite the growing demand for acupuncturists, changes to
11	standards for national certifications, and expanded accredited
12	educational programs, which now include master's and doctoral
13	level degrees.
14	Accordingly, the purpose of this Act is to make
15	comprehensive updates to chapter 436E, Hawaii Revised Statutes,

16 regarding acupuncture practitioners to reflect modernized scopes
17 of practice and licensing requirements.

1	SECT	ION 2. Chapter 436E, Hawaii Revised Statutes, is
2	amended b	y adding two new sections to be appropriately
3	designate	d and to read as follows:
4	" <u>§43</u>	6E-A Requirements for initial licensure. (a) To
5	qualify f	or licensure after July 1, 2025, an applicant shall
6	submit ev	idence satisfactory to the board that the applicant
7	meets the	following educational and examination requirements:
8	(1)	An individual applying for initial licensure shall
9		have successfully completed an acupuncture medicine
10		program from an accredited acupuncture medicine
11		institution; provided that those applicants who
12		graduated with an earned master's degree may apply to
13		the board for the "L.Ac." license designation, and
14		those applicants who graduated with an earned
15		doctorate degree may apply to the board for the
16		"D.Ac." license designation; and
17	(2)	All applicants for initial licensure shall pass
18		examinations and be certified by the National
19		Certification Commission for Acupuncture and Oriental
20		Medicine, or its successor entity.

- 1 (b) Applicants who have earned a bachelor's, master's, or
- 2 doctoral degree from a foreign university or college shall
- 3 demonstrate curricula and standards equivalent to or higher than
- 4 accredited acupuncture medicine institutions in the United
- 5 States, which have been recognized and approved by the board.
- 6 The board may contract with a third-party agency to determine
- 7 equivalency, at cost to the applicant.
- 8 §436E-B Legacy exemptions. Any existing acupuncture
- 9 licensees in the State as of July 1, 2025, shall be designated
- 10 legacy status by the board for their current license
- 11 designation, allowing for the practice of acupuncture medicine.
- 12 If a license that was issued before July 1, 2025, lapses and is
- 13 not restored within two years of its expiration date, the
- 14 licensee shall be subject to the licensure requirements pursuant
- 15 to section 436E-A."
- SECTION 3. Section 436E-1, Hawaii Revised Statutes, is
- 17 amended to read as follows:
- "[+] §436E-1[+] Declaration of necessity for regulation and
- 19 control. The legislature hereby finds and declares that
- 20 acupuncture medicine is an evidence-based medicine rooted in
- 21 traditional and modern modalities and that the practice of

- 1 acupuncture [is a theory and method for] medicine includes
- 2 examination, evaluation, diagnosis, and treatment of [illness
- 3 and disability and for strengthening and invigorating the body
- 4 and as such affects] the patient, therefore requiring regulation
- 5 and control as an essential service for public health, safety,
- 6 and welfare[, and therefore there is a necessity that
- 7 individuals practicing acupuncture be subject to regulation and
- 8 control]."
- 9 SECTION 4. Section 436E-2, Hawaii Revised Statutes, is
- 10 amended as follows:
- 1. By adding eight new definitions to be appropriately
- 12 inserted and to read:
- ""Accredited acupuncture medicine institution" means a
- 14 school or college accredited or recognized as a candidate for
- 15 accreditation by an acupuncture medicine accrediting body
- 16 recognized by the United States Department of Education.
- 17 "Acupuncture" means the integrative examination,
- 18 evaluation, diagnosis, prevention, and treatment of a physical,
- 19 mental, or emotional disease in the patient by stimulating
- 20 tissue by puncturing with a needle approved by the United States

- 1 Food and Drug Administration to various depths or utilizing
- 2 other means to achieve a response.
- 3 "Acupuncture medicine" means the evidence-based medicine
- 4 rooted in traditional theories and practices, integrated with
- 5 modern biomedical theories and practices.
- 6 "Acupuncture medicine doctor" means an acupuncture
- 7 practitioner engaged in the practice of advanced acupuncture
- 8 medicine.
- 9 "Licensed acupuncturist" or "L.Ac." means an acupuncture
- 10 practitioner who has complied with all educational and
- 11 professional examination requirements as determined by the board
- 12 and whose license remains in good standing with the board,
- 13 utilizing the license designation "L.Ac.".
- "Licensed doctor of acupuncture" or "D.Ac." means an
- 15 acupuncture medicine doctor who has complied with all
- 16 educational and professional examination requirements as
- 17 determined by the board and whose license remains in good
- 18 standing with the board, utilizing the license designation
- 19 "D.Ac.".
- 20 "Practice of acupuncture medicine" means the practice of
- 21 acupuncture with adjunctive therapies, including but not limited

- 1 to manual, mechanical, electrical, light, sound,
- 2 electromagnetic, thermal therapy, herbal and nutraceutical
- 3 medicines, lifestyle and nutritional counseling, movement, and
- 4 other traditional and modern techniques as further determined by
- 5 rule.
- 6 "Practice of advanced acupuncture medicine" means the
- 7 practice of acupuncture medicine as further determined by rule."
- 8 2. By amending the definition of "acupuncture"
- 9 practitioner" to read:
- 10 ""Acupuncture practitioner" means a person engaged in the
- 11 practice of acupuncture [→] medicine."
- 12 3. By repealing the definition of "practice of
- 13 acupuncture".
- 14 [""Practice of acupuncture" means stimulation of a certain
- 15 acupuncture point or points on the human body for the purpose of
- 16 controlling and regulating the flow and balance of energy in the
- 17 body. The practice includes the techniques of piercing the skin
- 18 by inserting needles and point stimulation by the use of
- 19 acupressure, electrical; mechanical, thermal, or traditional
- 20 therapeutic means."]

SECTION 5. Section 436E-3, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§436E-3 License or permit required. Except as otherwise 4 provided by law, no person shall engage in the practice of acupuncture medicine or practice of advanced acupuncture 5 medicine or use the title "acupuncturist" in [this] the State, 6 7 either gratuitously or for pay, [or shall offer to so practice, 8 or shall announce themselves either publicly or privately as 9 prepared or qualified to so practice any method of acupuncture] 10 without having [a valid unrevoked license or] an acupuncture 11 medicine intern permit [from the State; provided that the requirement for a permit shall not be enforced until the board 12 13 has initially adopted rules] pursuant to section 436E-3.6[-] or an L.Ac. or D.Ac. designation from the board." 14 SECTION 6. Section 436E-3.5, Hawaii Revised Statutes, is 15 16 amended to read as follows: 17 "§436E-3.5 Physicians and osteopaths not exempt. (a) Persons licensed under chapter 453 who desire to engage in the 18 19 practice of acupuncture medicine shall be subject to licensing

under this chapter.

1 The board may establish an alternative pathway for physician licensure in acupuncture in accordance with existing 2 3 Centers for Medicare and Medicaid Services guidelines." 4 SECTION 7. Section 436E-3.6, Hawaii Revised Statutes, is 5 amended to read as follows: 6 "[+] \$436E-3.6[+] Acupuncture medicine intern permit 7 required. [(a) Except as otherwise provided by law, no] No 8 person shall engage in the practice [as an] of acupuncture 9 medicine as an intern in this State, either gratuitously or for 10 pay, [without having first obtained a permit from the board. 11 This permit shall entitle the applicant to engage in the 12 practice of acupuncture for a period of four years under the 13 immediate supervision of a licensed acupuncturist duly licensed under this chapter. 14 15 (b) An acupuncture intern permit may be reissued once, for 16 a period not to exceed one year, upon written request to the board and payment of the required fee. 17 18 (c) The board shall adopt rules pursuant to chapter 91 19 defining the functions of an acupuncture intern, establishing 20 the requirements to be met by an applicant for an acupuncture 21 intern permit, and specifying the procedures for the immediate

Any license so forfeited may be restored within [one year] two years after the expiration upon filing of an 16 application and payment of a restoration fee. 17 (b) Beginning with the renewal for the licensing biennium 18 commencing July 1, 2025, and every biennial renewal thereafter, 19 **20** all licensees shall be in compliance with continuing education requirements, as approved by the board, by obtaining at least 21

- 1 thirty credit hours, which shall include at least two credit
- 2 hours of ethics and at least two credit hours of safety. The
- 3 board shall adopt rules relating to the requirements and
- 4 standards that continuing education programs shall meet to
- 5 obtain recognition and approval from the board.
- 6 (c) To determine compliance with the continuing education
- 7 requirements under subsection (b), the board may conduct a
- 8 random audit of licensees. A licensee selected for audit shall
- 9 be notified by the board. Within sixty days of notification,
- 10 the licensee shall provide the board documentation to verify
- 11 compliance with the continuing education requirements.
- 12 (d) Licensees shall hold a current and valid
- 13 cardiopulmonary resuscitation certification."
- 14 SECTION 10. Section 436E-10, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§436E-10 Revocation or suspension of licenses[-];
- 17 penalties. (a) In addition to any other actions authorized by
- 18 law, any license to engage in the practice of acupuncture
- 19 medicine or practice of advanced acupuncture medicine under this
- 20 chapter may be revoked or suspended by the board [of
- 21 acupuncture] at any time in a proceeding before the board for

19	(b)	Any person who practices, treats, or instructs in any
20	phase of a	acupuncture medicine, or uses any word or title to

any type of acupuncture medicine, without a license or permit issued by the board, shall be guilty of a misdemeanor and 2 3 subject to a fine of not less than \$1,000 for each day of 4 violation. The board may also seek all legal and equitable 5 remedies available to it for the enforcement of the provisions 6 of this chapter, including injunctive relief." 7 SECTION 11. Section 436E-5, Hawaii Revised Statutes, is 8 repealed. 9 ["\$436E-5 Qualifications for examination. (a) No person 10 shall be licensed to practice acupuncture unless the person has 11 passed an examination and has been found to have the necessary 12 qualifications as prescribed in the rules adopted by the board 13 pursuant to chapter 91. 14 (b) Prior to September 1, 2000, and except as provided in 15 subsection (c), before any applicant shall be eligible for the 16 examination, the applicant shall furnish satisfactory proof to 17 the board that the applicant has received a total of not less 18 than one thousand five hundred hours of education and training consisting of: 19

1	(1)	A formal program in the science of acupuncture
2		(traditional oriental medicine) at an institute or
3		school approved by the board that:

9	:	altered its program so as to lower the standards for
10		completion of the program. These students may qualify

21	September	1, 2000, before any applicant shall be eligible to

1 take the licensing examination, the applicant shall furnish 2 satisfactory proof to the board that the applicant has completed 3 a formal acupuncture program and has received a total of at 4 least two thousand, one hundred seventy five hours of academic 5 and clinical training consisting of an academic program of at 6 least one thousand, five hundred fifteen hours in the science of 7 acupuncture (traditional oriental medicine) and a clinical 8 training program of at least six hundred sixty hours under the 9 supervision of a licensed acupuncturist, which shall result in 10 the award of a certificate or diploma. For applicants who graduated from an institute, school, or college located in the 11 12 United States or any territory under the jurisdiction of the 13 United States, the institute, school, or college shall be 14 accredited or recognized as a candidate for accreditation by any 15 acupuncture or oriental medicine accrediting body recognized by 16 the United States Department of Education. For applicants who 17 graduated from a foreign institute, school, or college with a 18 formal program in the science of acupuncture, the applicant, at 19 the applicant's own expense, shall have the applicant's 20 transcripts and curriculum evaluated by a board approved and 21 designated professional evaluator who shall make a determination

1 whether the transcripts and curriculum are at least equivalent 2 to that of the United States accredited acupuncture program, and 3 that the foreign institute is licensed, approved, or accredited 4 by the appropriate governmental authority or an agency recognized by a governmental authority in the respective foreign 5 6 jurisdiction and whose curriculum is approved by the board."] 7 SECTION 12. Section 436E-12, Hawaii Revised Statutes, is 8 repealed. 9 ["[§436E-12] Penalty. (a) Any person except a person 10 licensed under this chapter who practices, treats, or instructs 11 in any phase of acupuncture without a license or permit issued 12 by the board, or uses any word or title to induce the belief 13 that they are engaged in the practice of any type of acupuncture, shall be quilty of a misdemeanor and subject to a 14 fine of not less than \$50 nor more than \$1,000 for each 15 violation. 16 17 (b) Any person, except a licensed acupuncturist, who: 18 (1) Practices or attempts to practice acupuncture; (2) Buys, sells, or fraudulently obtains any diploma or 19 20 license to practice acupuncture whether recorded or 21 not:

1	(3) Uses the title "acupuncturist", "D.Ac." or "D.O.M." or
2	any word or title to induce the belief that the person
3	is engaged in the practice of acupuncture without
4	complying with this chapter; or
5	(4) Violates this chapter;
6	shall be penalized as provided in subsection (a). The

10	SECTION 13. Section 436E÷13, Hawaii Revised Statutes, is
11	repealed.
12	["§436E-13 Use of titles: (a) A licensee who has been
13	awarded a license to practice acupuncture by the board in this
14	State may use the title of "Licensed Acupuncturist" or
15	designation "L.Ac." with the licensee's name in an advertisement
16	for acupuncture or announce or append the designation to the
17	licensee's name.
18	(b) A licensee who has been awarded an earned doctoral
19	degree may use the designation "Ph.D." in an advertisement for
20	acupuncture or announce or append the designation to the
21	licensee's name if the degree was granted from a university or

1 college recognized by a regional or national accrediting body 2 recognized by the United States Department of Education. A 3 Ph.D. recognized by the board under this subsection shall 4 designate a nonpractitioner as opposed to a practitioner or 5 "doctor" of acupuncture as provided in subsection (c). 6 (c) A licensee who has been approved by the board to use 7 the doctor of acupuncture title, may use the title "Doctor of 8 Acupuncture" or designation of "D.Ac.", after the licensee's 9 name, or the term "Doctor" or prefix "Dr." provided that the 10 word "Acupuncturist" immediately follows the licensee's name if 11 the term "Doctor", or the prefix "Dr." is used alone. 12 (d) Before any licensee shall be eligible to use the 13 doctor of acupuncture title, the licensee shall furnish 14 satisfactory proof to the board that the licensee has been 15 awarded an earned doctoral degree in acupuncture (traditional 16 oriental medicine). For licensees who graduated from an 17 institute, school, or college located in the United States or 18 any territory under the jurisdiction of the United States, the 19 institute, school, or college shall be accredited or recognized 20 as a candidate for accreditation by a regional or national 21 accrediting body that is recognized by the United States

Department of Education for the accreditation or 1 2 pre accreditation ("candidacy") of professional post-graduate doctoral programs in acupuncture and oriental medicine. For 3 4 licensees who graduated from a foreign institute, school, or 5 college, the licensee, at the licensee's own expense, shall have 6 the licensee's transcripts and curriculum evaluated by a board approved and designated professional evaluator who shall make a 7 8 determination on whether the transcripts and curriculum are at 9 least equivalent to the United States recognized doctoral 10 program of study in acupuncture and oriental medicine, and that 11 the foreign institute is licensed, approved, or accredited by 12 the appropriate governmental authority or an agency recognized by a governmental authority in the respective foreign 13 14 jurisdiction and whose curriculum is approved by the board. 15 (e) Except as provided in this section, use of other titles, prefixes, or designations shall not be permitted."] 16 SECTION 14. Section 436E-14, Hawaii Revised Statutes, is 17 repealed. 18 ["[§436E-14] Foreign school curricula and standards. The 19 20 board of acupuncture shall not recognize and approve an earned doctoral degree from a foreign university or college whose 21

- curricula and standards are not equivalent to or higher than
 institutions in the United States which have been recognized and
 approved by the board in the study or practice of acupuncture."]
- 4 SECTION 15. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2023-2024 and
- 7 the same sum or so much thereof as may be necessary for fiscal
- 8 year 2024-2025 for the department of commerce and consumer
- 9 affairs' professional and vocational licensing division to
- 10 update its internal database for the purposes of this Act.
- 11 The sums appropriated shall be expended by the department
- 12 of commerce and consumer affairs for the purposes of this Act.
- 13 SECTION 16. In codifying the new sections added by section
- 14 2 of this Act, the revisor of statutes shall substitute
- 15 appropriate section numbers for the letters used in designating
- 16 the new sections in this Act.
- 17 SECTION 17. Statutory material to be repealed is bracketed
- 18 and stricken. New statutory material is underscored.
- 19 SECTION 18. This Act shall take effect on December 31,
- **20** 2050.

Beginning with the renewal for the licensing biennium commencing 7/1/2025, requires licensees to obtain thirty hours of continuing education per licensing biennium. Appropriates funds to the Department of Commerce and Consumer Affairs to update the Professional and Vocational Licensing Division's internal database. Effective 12/31/2050. (SD1)
