## A BILL FOR AN ACT

RELATING TO HOUSING SAVINGS ACCOUNTS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) The legislative reference bureau shall
- 2 propose a system for the establishment and implementation of a
- 3 housing savings account program for the State, and shall
- 4 evaluate and report on the viability of the proposed system.
- 5 The legislative reference bureau may contract for services to
- 6 conduct the study required under this Act.
- 7 (b) The information reported on the proposed housing
- 8 savings account system shall consist of:
- 9 (1) Contributions of an employee; and
- 10 (2) Contributions of an employer matched to the
- 11 contributions of an employee.
- 12 (c) Funds contributed under the proposal for a housing
- 13 savings account system shall be utilized for the following
- 14 purposes:
- 15 (1) Downpayments;
- 16 (2) Mortgage payments;
- 17 (3) Rent;



1	(4)	Security deposits; and
2	(5)	Any other lawful purpose.
3	(d)	The study shall consider the following:
4	(1)	Problems or barriers to the implementation of a
5		housing savings account system;
6	(2)	Attitudes and concerns among residents and employees
7		in the State regarding a housing savings account
8		system;
9	(3)	Components required for a housing savings account to
10		be feasible in the State;
11	(4)	The feasibility of including independent contractors
12		in the housing savings account system;
13	(5)	A mechanism that exempts moneys in the housing savings
14		account from an individual's total assets as
15		calculated under title 24 Code of Federal Regulations
16		section 5.609 in order to prevent those in public
17		housing from being disqualified from those programs;
18		and
19	(6)	Any other matters deemed necessary or relevant to the
20		study.

- 1 (e) The legislative reference bureau shall submit a report
- 2 of its proposal, findings, and recommendations, including any
- 3 proposed legislation, to the legislature no later than twenty
- 4 days prior to the convening of the regular session of 2025.
- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$500,000 or so much
- 7 thereof as may be necessary for fiscal year 2023-2024 and the
- 8 same sum or so much thereof as may be necessary for fiscal year
- 9 2024-2025 for the legislative reference bureau to contract for
- 10 services to conduct the study required under this Act.
- 11 The sums appropriated shall be expended by the legislative
- 12 reference bureau for the purposes of this Act.
- 13 SECTION 3. This Act shall take effect on July 1, 2023.
