## SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO ASSESS THE SOCIAL AND FINANCIAL EFFECTS OF MANDATORY HEALTH INSURANCE COVERAGE FOR BIOMARKER TESTING.

1 WHEREAS, biomarker testing is an invaluable tool in the diagnosis, treatment, appropriate managements, and ongoing 2 monitoring of diseases or conditions; and 3 4 5 WHEREAS, biomarker testing is the analysis of a patient's tissue, blood, or other biospecimen for the presence of a 6 7 biomarker, a type of precision medicine that looks for genes, proteins, and other substances that can provide information 8 9 about a patient's chronic condition; and 10 11 WHEREAS, biomarker testing allows for a more precise and personalized approach to medical care by identifying specific 12 genetic, molecular, or biochemical markers associated with an 13 14 individual's disease; and 15 WHEREAS, biomarker testing enables health care providers to 16 tailor treatments based on the unique characteristics of 17 a patient's condition, leading to more effective and targeted 18 interventions: and 19 20 WHEREAS, despite the fact that biomarker testing is 21 22 essential to high-quality, personalized care to treat serious illness and enhance patients' quality of life, patients cannot 23 easily access it; and 24 25 26 WHEREAS, House Bill No. 2223, House Draft No. 1, Regular Session of 2024, require insurers, mutual benefit societies, and 27 health maintenance organizations to provide coverage for 28 medically necessary biomarker testing for the purposes of 29 30 diagnosis, treatment, appropriate management, or ongoing

monitoring of a person's disease or condition to guide treatment 1 decisions when supported by medical and scientific evidence; and 2 3 WHEREAS, pursuant to section 23-51, Hawaii Revised 4 5 Statutes, before any legislative measure that mandates health insurance coverage for specific health services, specific 6 diseases, or certain providers of health care services as part 7 of individual or group health insurance policies, can be 8 9 considered, concurrent resolutions shall be passed that designate a specific legislative bill for the Auditor to review 10 11 and prepare a report for submission to the Legislature that assesses both the social and financial effects of the proposed 12 mandated coverage under that legislative bill; and 13 14 WHEREAS, section 23-52, Hawaii Revised Statutes, further 15 specifies the minimum information required for assessing the 16 17 social and financial impact of the proposed health coverage mandate in the State Auditor's report; now, therefore, 18 19 20 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the 21 22 House of Representatives concurring, that the Auditor is requested to assess, in accordance with sections 23-51 and 23 23-52, Hawaii Revised Statutes, the social and financial effects 24 of mandating health insurance coverage for medically necessary 25 biomarker testing for the purposes of diagnosis, treatment, 26 appropriate management, or ongoing monitoring of a person's 27 28 disease or condition to guide treatment decisions when supported by medical and scientific evidence, as provided in House Bill 29 No. 2223, House Draft No. 1, Regular Session of 2024; and 30 31 BE IT FURTHER RESOLVED that the Auditor is requested to 32 33 submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than 34 twenty days prior to the convening of the Regular Session of 35 2025; and 36 37 38 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Auditor, Director of 39 Commerce and Consumer Affairs, and Insurance Commissioner. 40 41 42
