## SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF AGRICULTURE TO ADOPT PROPOSED AMENDMENTS TO CHAPTER 4-72, HAWAII ADMINISTRATIVE RULES, THAT PROVIDE IMPORTANT AUTHORITIES FOR THE DEPARTMENT TO PREVENT THE SPREAD OF INSECTS, DISEASES, AND OTHER INVASIVE PESTS WITHIN THE STATE.

WHEREAS, the Department of Agriculture (Department) has the sole authority to quarantine or prevent the movement of an invasive pest or material infested with an invasive pest in the State, and therefore all other state departments, county governments, and the industries, environment, and people of the State rely on the Department to prevent the spread of pests within the State; and

9 WHEREAS, chapter 4-72, Hawaii Administrative Rules (HAR),
10 entitled "Plant and Non-Domestic Animal Quarantine Plant
11 Intrastate Rules" is the only chapter available to the
12 Department's Plant Industry Division to regulate the movement of
13 pests within the State; and

15 WHEREAS, the Department has proposed amendments to chapter 16 4-72, HAR, that provide important authorities for the Department 17 to prevent the spread of insects, diseases, and other invasive 18 pests within the State; and 19

WHEREAS, these amendments were unanimously moved forward by the Advisory Committee on Plants and Animals on February 15, 2023, the Board of Agriculture on February 28, 2023, and the Small Business Regulatory Review Board on May 30, 2023, and each of these approvals occurred at a noticed public meeting that provided the opportunity for written and oral public testimony; and

28 WHEREAS, coconut rhinoceros beetle, coqui frog, and little 29 fire ants are rapidly spreading across and within the islands of 30 the State and the authorities provided and clarified in the

proposed amendments will allow the Department to prevent and 1 slow the spread of these and other pests; and 2 3 WHEREAS, many people are shocked to learn that it is not 4 illegal to sell plants or other merchandise known to be infested 5 with a pest, and that instead, section 141-2, Hawaii Revised 6 7 Statutes, provides the Department the authority to adopt administrative rules to prevent such sales; and 8 9 10 WHEREAS, the proposed amendments to chapter 4-72, HAR, are the Department's first attempt to adopt rules to prevent the 11 sale of pest-infested merchandise, which will protect the 12 State's agricultural industries, natural resources, consumers, 13 and the public; and 14 15 WHEREAS, the proposed rule amendments are a sensible and 16 important step forward from the Department's current approach, 17 18 which is to ask a seller to stop selling pest-infested 19 merchandise on a voluntary basis; and 20 21 WHEREAS, the authority provided in proposed section 4-72-5, HAR, authorizes the Department to stop the movement of 22 23 merchandise that is infested with a pest and for sale to the public, such as plants infested with little fire ants, by 24 businesses that sell directly to the public; and does not apply 25 26 to farms, ranches, or other agricultural production areas that do not sell directly to the public on-site; and 27 28 29 WHEREAS, the Department held a noticed public hearing on the proposed amendments to chapter 4-72, HAR, on January 30, 30 31 2024, and now is the time to move the amendments forward toward 32 adoption; and 33 WHEREAS, the Legislature recognizes the amendments proposed 34 by the Department to chapter 4-72, HAR, include and clarify 35 authorities that will allow the Department to prevent and slow 36 the spread of high-impact invasive pests, such as coconut 37 rhinoceros beetle, coqui frog, and little fire ants; and 38 39 40 WHEREAS, other state departments, county governments, and the industries, environment, and people of the State are relying 41 on the Department to adopt the proposed amendments to chapter 42

4-72, HAR, which are urgently needed to address pests spreading 1 within the State; now, therefore, 2

BE IT RESOLVED by the Senate of the Thirty-second 4 Legislature of the State of Hawaii, Regular Session of 2024, the 5 House of Representatives concurring, that the Department of 6 Agriculture is urged to adopt proposed amendments to chapter 7 8 4-72, Hawaii Administrative Rules, that provide important authorities for the Department to prevent the spread of insects, 9 10 diseases, and other invasive pests within the State; and

12 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Governor, 13 14 Chairperson of the Board of Agriculture, and Mayors of each 15 county.
