REQUESTING THE DEPARTMENT OF AGRICULTURE TO ESTABLISH A SUSTAINABLE FOOD SYSTEMS WORKING GROUP.

WHEREAS, a sustainable food system is a food system in which producers, retailers, community members, non-governmental organizations, and government agencies partner to create a vibrant and resilient local food economy that enhances and sustains the environmental, economic, and social health of the community; and

WHEREAS, the development of a more sustainable food system for Hawaii represents an opportunity to create a new food economy that integrates the objectives of "green" job creation, sustainable economic development, land stewardship, food security, environmental protection, and climate change resiliency with community health and well-being; and

WHEREAS, the State needs a coordinated, comprehensive, and unified approach to building a sustainable food system; now, therefore,

BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the House of Representatives concurring, that the Department of Agriculture is requested to establish a Sustainable Food Systems Working Group; and

BE IT FURTHER RESOLVED that the Sustainable Food Systems Working Group is requested to consist of the following members;

(1) The Deputy to the Chairperson of the Board of Agriculture, who is also requested to serve as chairperson of the Sustainable Food Systems Working Group;
