Your Committee on Agriculture & Food Systems, to which was referred H.B. No. 1426 entitled:

"A BILL FOR AN ACT RELATING TO VALUE-ADDED PRODUCTS,"

begs leave to report as follows:

The purpose of this measure is to establish a food and product innovation network, which is a statewide network of openaccess food and value-added product development facilities to enable businesses to scale up new products from research and development to manufacturing and commercialization.

Your Committee received testimony in support of this measure from the Department of Agriculture, Agribusiness Development Corporation, University of Hawai'i Community Colleges, Hawai'i Farm Bureau, Ulupono Initiative, Agriculture & Food Security Committee of the Environmental Caucus of The Democratic Party of Hawai'i, and Food+ Policy Internship 2023. Your Committee received comments on this measure from the County of Hawai'i, Hāmākua Institute, and The Food Basket Inc. - Hawai'i Island's Food Bank.

Your Committee finds that a network of open-access food and value-added product development facilities in Hawaii would support the production of new value-added products so that farmers in the State can increase their incomes while allowing locally-produced value-added goods to compete with imported products, expand into



new export markets, and capitalize on the Hawaii brand, thereby strengthening the local economy.

Your Committee has amended this measure by:

- (1) Inserting appropriations of unspecified sums for:
 - (A) One open-access food and value-added product development facility in Hilo on the island of Hawaii; and
 - (B) One open-access food and value-added product development facility in Kailua-Kona on the island of Hawaii;
- (2) Changing its effective date to June 30, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.


