"A BILL FOR AN ACT RELATING TO ADAPTATION PATHWAYS PLANNING,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Require the Department of Land and Natural Resources, in cooperation with appropriate state and county agencies, to prepare and revise regional-scale adaptation pathways plans to lower the risk of flooding and loss due to the sea level rising progressively over time; and
- (2) Appropriate funds for the Department to identify appropriate communities for and initiate preparation of one regional sea level rise adaptation pathways plan per county.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources; Office of Planning and Sustainable Development; one member of the Maui County Council; Hawaii Reef and Ocean Coalition; Surfrider Foundation, Hawai'i Region; and two individuals. Your Committee received comments on this measure from the University of Hawai'i
