Your Committee on Agriculture & Food Systems, to which was referred H.B. No. 1815 entitled:

"A BILL FOR AN ACT RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION,"

begs leave to report as follows:

The purpose of this measure is to include agritourism in the definition of "enterprise" to authorize the Agribusiness Development Corporation to financially support businesses engaged in agritourism.

Your Committee received testimony in support of this measure from the Agribusiness Development Corporation; Hawai'i Farm Bureau; and one individual. Your Committee received testimony in opposition to this measure from four individuals. Your Committee received comments on this measure from one individual.

Your Committee finds that environmental, technological, and other global changes have opened doors to new opportunities for agricultural growth and development in the State. With the State's goal of achieving increased food self-sufficiency, it is essential that the Agribusiness Development Corporation continue to support more agricultural businesses, including those engaged in agritourism to support the viability of their business models,
