"A BILL FOR AN ACT RELATING TO COMPENSATION FOR COURT-APPOINTED REPRESENTATION,"

The purpose of this measure is to increase the rate of compensation and maximum allowable amounts per case for courtappointed counsel and guardians ad litem in family court proceedings and appropriate funds to pay these increased amounts.
