Your Committee on Finance, to which was referred H.B. No. 2696, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO LAHAINA WILDFIRE RECOVERY," begs leave to report as follows:

The purpose of this measure is to:

- (1) Establish and appropriate funds for the Lahaina Recovery Oversight Commission to oversee and guide the recovery of Lahaina from the 2023 wildfires; and
- (2) Require the Office of Enterprise Technology Services to assist in establishing a website for the Commission that will serve as a clearinghouse for information related to the Lahaina wildfire recovery and a forum for public input.
