Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2845, S.D. 2, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO FIREARMS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to prohibit:

- A person from selling ammunition to a person under the age of twenty-one; and
- (2) A person under the age of twenty-one from owning, possessing, or controlling ammunition, with exceptions.

Your Committee on Conference finds that setting a minimum age requirement to purchase, own, or possess ammunition that conforms to the existing minimum age requirement to purchase, own, or possess a firearm in the State will help to ensure the safety of residents and


