The purpose of this measure is to:

- (1) Establish within the Statewide Office of Homelessness and Housing Solutions a working group to develop a Homeless Triage and Treatment Center Program; and
- (2) Appropriate funds for the establishment of the working group and implementation of the Homeless Triage and Treatment Center Program.

Your Committee received testimony in support of this measure from the Governor's Coordinator on Homelessness; Aloha United Way; The Institute for Human Services, Inc.; and one individual. Your Committee has amended this measure by changing its effective date to July 1, 3000, to encourage further discussion.
