"A BILL FOR AN ACT RELATING TO PEER SUPPORT SPECIALISTS,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Establish a working group within the Office of Wellness and Resilience to create a statewide framework for peer support specialists, identify a trauma-informed model of supervision of peer support specialists, provide an inventory of current use of peer support specialists, and develop a sustainability plan to establish peer support as a Medicaid billable service; and
- (2) Appropriate funds for the working group and hiring of an administrative facilitator to support the working group.

Your Committee received testimony in support of this measure from the Judiciary; Office of Wellness and Resilience; Department of Human Services; State Council on Developmental Disabilities; State Council on Mental Health; Hawaii Substance Abuse Coalition; Hawai'i Youth Services Network; EPIC 'Ohana, Inc.; Commit to Keiki; Hawai'i Children's Action Network Speaks!; Opportunity Youth Action
