Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 3157, S.D. 2, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO DIRECT NEGOTIATION FOR PUBLIC LAND LEASES,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to expand the disposition of public land leases through direct negotiation to include commercial and industrial purposes.

Your Committee on Conference finds that the public auction process used for the disposition of public lands discourages potential lessees. Consequently, properties have remained vacant, generating no income and serving no public benefit, while in some cases incurring significant management costs for the Department of Land and Natural Resources. This measure will facilitate the productive use of public lands by authorizing the disposition of

public land leases through direct negotiation for commercial and industrial purposes.
