Repeals the exemption of the Hawaii Tourism Authority from administrative supervision of boards and commissions. Transfers certain functions relating to cultural grants from the Hawaii Tourism Authority to the State Foundation on Culture and the Arts. Effective 7/1/3000. (HD1)	TOU, CAI, FIN
<u>HB 2246, HD1</u> (<u>HSCR65-24)</u> <u>Status</u>	RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS. Transfers the awarding and administration of certain cultural grants from the Hawaii tourism authority to the state foundation on culture and the arts and establishes a standing selection committee within the foundation to review and award the cultural grants. Appropriates funds for grant administrator positions. Effective 7/1/3000. (HD1)	TOU, CAI, FIN
