RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS. EET/TCA, WAM

Transfers the awarding and administration of certain cultural grants from the Hawaii Tourism Authority to the State Foundation on Culture and the Arts and establishes a standing selection committee within the Foundation to review and award the cultural grants. Appropriates funds for grant administrator positions. Effective 7/1/3000. (HD2)

RELATING TO THE HAWAII TOURISM AUTHORITY. EET/TCA, WAM

Repeals the exemption of the Hawaii Tourism Authority from administrative supervision of boards and commissions. Transfers certain functions relating to cultural grants from the Hawaii Tourism Authority to the State Foundation on Culture and the Arts. Effective 7/1/3000. (HD1)

RELATING TO ELECTRIC VEHICLE PARKING.

TCA/EET, JDC

Removes the exemption that allowed owners of multiple parking facilities within the State to designate and electrify fewer parking spaces than required in one or more of the properties if the requirement for the total number of aggregate spaces on all of their owned properties was met. Authorizes the counties to adopt ordinances to regulate electric vehicle charging systems for places of public accommodation with fewer than one hundred parking spaces. Effective 7/1/3000. (HD2)

Decision Making to follow, if time permits.
