Clarifies the powers of the Governor and mayors to extend or terminate a state of emergency. Shortens the duration of price control periods from ninety-six hours to seventy-two hours. | <u>HB 1840, HD1</u> (HSCR408-24) <u>Status</u> | RELATING TO THE ENVIRONMENT. Appropriates funds to the Department of Land and Natural Resources to support long-term water quality monitoring and pollution source detection. Effective 7/1/3000. (HD1) | WAL/EEP, FIN |



| <u>HB 1841, HD1</u> (<u>HSCR319-24)</u> <u>Status</u> | RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES. Appropriates funds to DLNR for operating expenses, equipment, the establishment of positions, and capital improvement projects to support wildfire emergency response. Effective 7/1/3000. | <u>HB 2407, HD2</u> (<u>HSCR620-24)</u> <u>Status</u> | RELATING TO WILDFIRE RISK MITIGATION. Creates a process for electric utilities to develop and submit wildfire protection plans to the Public Utilities Commission for approval and allow the recovery of related costs and expenses through securitization, while avoiding a disproportionate impact on a specific ratepayer or county. Effective 7/1/3000. (HD2) | WAL/EEP, CPC/JHA, FIN |
