Establishes: (1) a fee of \$10 for the issuance of an apostille or non-apostille certification; and (2) the Apostilles and Certifications Special Fund. Authorizes the Office of the Lieutenant Governor to expend moneys in the special fund for operational expenses. Requires all state agencies to: (1) before adopting, amending, or repealing an administrative rule, provide electronic notice of the proposed rulemaking to certain persons: (2) when adopting, amending, or repealing an administrative rule, display changes to the rules in Ramseyer format; and (3) make the full text of their rules available on the Office of the Lieutenant Governor's internet website in a digitally accessible and searchable format.
