SB 3296 RELATING TO REMOTE WORK. LBT/GVO, WAM

Status & Testimony

Requires the Department of Human Resources Development to:
(1) conduct a remote work study; (2) review any recent remote work studies done by the counties; (3) develop and administer a remote work program; and (4) submit the study to the

Legislature prior to the convening of the Regular Session of 2025. Declares that the general fund expenditure ceiling is

exceeded. Makes an appropriation.

SB 3297 RELATING TO EMPLOYMENT. LBT/GVO, WAM

Requires and appropriates moneys for the Department of Human Resources Development to submit an annual report on vacancies, recruitment efforts, and retention policies in the State's Executive Branch. Declares that the appropriation

exceeds the state general fund expenditure ceiling for 2024-

2025.
