Requires matching funds from public utilities. Effective Status & 7/1/3000. (HD2)

Facilitates the control and eradication of invasive species and (HSCR701-24) pests. Establishes a plant nursery licensing program. Requires the Board of Agriculture to designate certain species as pests Status & for control or eradication. Imposes certain limits on imports and Testimony

transportation. Updates the method by which the Department's noxious weed list is updated. Effective 7/1/3000. (HD2)
