DECISION MAKING ONLY

<u>HB 1594</u> <u>Status</u>	RELATING TO INTOXICATING LIQUOR. Prohibits any person convicted of operating a vehicle under the influence of an intoxicant or habitually operating a vehicle under the influence of an intoxicant from purchasing or publicly consuming alcohol for a certain period.	TRN, JHA
<u>HB 1935</u> <u>Status</u>	RELATING TO THE USE OF INTOXICANTS WHILE OPERATING A VEHICLE. Lowers the threshold blood alcohol concentration for the offenses of operating a vehicle under the influence of an intoxicant and habitually operating a vehicle under the influence of an intoxicant.	TRN, JHA

<u>HB 1576</u> <u>Status</u>	RELATING TO VEHICLE NUMBER PLATES. Allows owners of vehicles to display the front number plate on the inside of the front windshield as an alternative to being securely fastened to the front of the vehicle.	TRN, JHA
<u>HB 1579</u> <u>Status</u>	RELATING TO WINDSHIELD TINTING. Lowers the level of light transmittance allowed on sun screening glazing on motor vehicle windows from thirty-five per cent to twenty per cent.	TRN, JHA
HB 1569 Status	RELATING TO MOTOR VEHICLES. Prohibits the sale of certain new motor vehicles that do not use light emitting diode bulbs for any exterior and interior lights.	TRN, JHA
<u>HB 1531</u> <u>Status</u>	RELATING TO MOTOR VEHICLE INSURANCE. Makes mandatory the suspension of the driver's license of a driver or registered owner of a vehicle for operating a motor vehicle without a motor vehicle insurance policy. Increases duration of suspension of driver's license for violations.	TRN, JHA
<u>HB 1936</u> <u>Status</u>	RELATING TO HARBOR SAFETY. Requires that the securing of mooring lines from vessels requiring tug assistance to commercial docks, wharves, piers, quays, and landings be performed by a stevedoring company. Defines "stevedoring company." Exempts, under certain circumstances, vessels operating on behalf of an authorized intrastate or transpacific water property carrier holding a certificate of public convenience and necessity issued under section 271G-10, HRS. Sunsets on 7/1/2028.	TRN, CPC
HB 2112 Status	RELATING TO MOPED INSURANCE. Requires that moped operators carry an insurance policy. Makes conforming amendments.	TRN, CPC
HB 2065 Status	RELATING TO EXCESSIVE NOISE. Amends the appropriation for fiscal year 2024-2025 for the Noise Traffic Pilot Program of the department of transportation.	TRN, FIN
<u>HB 2526</u> <u>Status</u>	RELATING TO MOTOR VEHICLES. Increases penalties for certain offenses relating to the unauthorized driving or operation of motor vehicles.	TRN, JHA
<u>HB 2580</u> <u>Status</u>	RELATING TO TRANSPORTATION. Prohibits the removal of a manufacturer- or factory-installed speed limiting device from an electric bicycle. Prohibits the operation of an electric bicycle, in which the manufacturer- or factory-installed speed limiting device was removed from the electric bicycle, on a public highway.	TRN, JHA



HB 2270 Status	RELATING TO THE DEPARTMENT OF TRANSPORTATION. Establishes a task force to develop and explore alternate routes into and out of the Waianae Coast, including through Kolekole pass and opening Waianae Coast emergency access road.	TRN, FIN
HB 2015 Status	RELATING TO THE DEPARTMENT OF TRANSPORTATION. Requires DOT to identify an emergency egress route other than Komo Mai drive from Pacific Palisades or, if no other route can be found, determine the feasibility of constructing an alternate emergency egress route.	TRN, FIN
HB 2175 Status	RELATING TO THE KAAAWA-HAUULA COMMUNITY-BASED LONG-RANGE TRANSPORTATION PLAN. Appropriates funds for and requires the involvement of community members and organizations in the development of a community-based long-range transportation plan for the Kaaawa and Hauula communities.	TRN, FIN
<u>HB 2702</u> <u>Status</u>	RELATING TO ROAD IMPROVEMENTS. Appropriates funds for equipment and one full time equivalent position within the Department of Transportation to conduct improvements on Hana Highway.	TRN, FIN
HB 1991 Status	RELATING TO MOTOR VEHICLE INSURANCE. Clarifies U-drive motor vehicle insurance policy requirements.	TRN, CPC
<u>HB 2380</u> <u>Status</u>	MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF BUDGET AND FINANCE. Makes an emergency appropriation to provide special funds for disbursements of moneys in the Mass Transit Special Fund.	TRN, FIN
<u>HB 2490</u> <u>Status</u>	RELATING TO CAPITAL ADVANCEMENT CONTRACTS. Increases the caps for the total contract value for any one capital advancement contract (CAC) and the total aggregate value of CACs in a fiscal year entered into by the Department of Transportation with private parties for harbor improvements and adds reporting requirements for the department.	TRN, FIN
HB 1856 Status	RELATING TO TRAFFIC REGULATION. Authorizes each county to adopt ordinances to regulate or restrict access to certain streets, highways, thoroughfares, or roads.	TRN, JHA
