Support for GM 512

Chair Keohokalole, Vice Chair Fukunaga, members of the Senate Committee, thank you for the opportunity to testify on GM 512. The Hawai'i State Center for Nursing supports the nomination of Bradley Kuo to the Hawai'i Board of Nursing.

The Hawai'i State Center for Nursing (HSCN) convenes a group, *APRN Policy and Practice Task Force.* Since 2015, Bradley Kuo has been a member of this group. In this working group, he has been instrumental in identifying opportunities and needs for APRNs, including those which have resulted in development of proposed legislation, produces public resources that increase the nursing understanding of laws and rules as well as public understanding of APRN roles, and has contributed to interprofessional working groups and dialogues that advance healthcare in Hawai'i.

Two initiatives that demonstrate Dr. Kuo's excellent fit for the Board of Nursing are as follows:

- Co-drafter of the APRN decision making framework, a collaborative effort of the Hawai'i Board of Nursing, Hawai'i State Center for Nursing, and Hawai'i Association of Professional Nurses. This framework enables the APRN nurse to process through their education, training, certifications, and licensure as it relates to patient care considerations to ensure that nurses perform clinical services to the top of their education and within the rule of the law.

- Co-lead with Hawai'i State Center for Nursing on the HRS Review to remove barriers to practice. In 2021 and 2022, the Hawai'i State House of Representatives introduced resolutions with the purpose of these measures included convening a working group to determine the gaps in access to health care and the scope of care of advanced practice registered nurses as well as to conduct an analysis regarding the scopes of practice for advanced practice registered nurses and physician assistants. Launching this working group in 2022, Dr. Kuo and I worked together to identify laws that pertain to healthcare practice. He secured a full list of these laws, created a spreadsheet that linked each statute to the HRS webpage, and has worked with me to facilitate an interprofessional working group that includes pharmacy, psychology, medicine, physician assistant, and advanced practice registered nurse members. Of over 500 statutes identified, today this working group has reviewed and drafted recommendations for 300 statutes, with recommendations for amendments to 50% of these statutes.

The mission of the Hawai'i State Center for Nursing is to engage in nursing workforce research, promote best practices and disseminate knowledge, cultivate a diverse and well–prepared workforce, support healthy work environments, champion lifelong learning, and strategically plan for sound nursing workforce policy.
