As a former student of hers, I strongly support Ms. Lauren Akitake for consideration and confirmation to the Board of Regents for the University of Hawaii.

Ms. Akitake was my Professor at UH Maui College where I had the opportunity to be one of her students in her Business Law class. I thoroughly enjoyed it and learned so many practical truths about the law that I had never known about prior to taking her class. I learned the ability to be able to analyze cases and develop and defend positions. She made learning very difficult and complex material, specifically "Business Law", much more manageable and interesting. She used examples and scenarios from many different cases, both local and international, that were broken down for our class to make it easier for us to understand and grasp the various concepts, which required using our critical thinking skills.

She once shared with us a case about Honolulu Cookie Company and Big Island Candies. She brought into class two different cookies for each of us and placed them in front of us on the table, one cookie from Cookie Corner and a cookie from Big Island Candies. She asked us if we could note any difference between the two. Big Island Candies sued locally owned Cookie Corner in July 2001 for trademark infringement. Ms. Akitake discussed trademark infringement with our class, what it meant, and how/when the law is applied, and what does or does not deserve legal protections. The best part of the lesson was, when it concluded, Ms. Akitake allowed us to eat both cookies! They were both delicious! She was always positive, interesting and engaging with our class, and most of all very creative in teaching difficult topics to get us to be able to help us understand the law, which can sometimes be very intimidating and daunting to learn about as a student with no prior knowledge about the subject.

What I learned from her class, I was, and am still able to apply it to my daily life. From learning about Torts, to Contracts, I learned valuable lessons that aided me in knowing what to do before signing any binding contracts that could potentially be catastrophic for me.

I am grateful to have had her as my former professor, and now, as my friend.

We write to offer our highest support for our daughter Lauren Mei-Siang Akitake to be confirmed as a Regent for the University of Hawaii, Maui County Seat. My wife and I are 45-year Maui residents, and I am a retired Pediatrician after a 35-year career with the Maui Medical Group. I am born and raised in Kalihi Valley, and my wife was born in China and raised in New Orleans, Louisiana. We met when I finished medical school at Tulane Medical School in Louisiana, and after residency at the University of Colorado Boulder, we made Maui our home, where Lauren and her older brother were born and raised.

We are deeply proud of Lauren and her achievements, but most importantly, we are so very proud of the woman Lauren has become. From a young age, Lauren has challenged herself and pushed herself outside of her comfort zone. As a child and teen, Lauren stood out: academically; as an athlete (she was in the top 5 in singles and top 2 in doubles in girls' tennis in Hawaii from 7 to 18 years old); and in her extracurricular activities as she was in just about every club at Iao Intermediate School and then HP Baldwin High School. She was, and is, a social butterfly who has been able to use her education and experience, coupled with her deep care for her community, to help others at every stop along her path.

Growing up relatively sheltered on Maui, when Lauren went away for college and beyond, she faced the reality of the larger world but persevered through many difficulties and barriers. She has shown patience despite having faced negative opinions (possibly rooted in ignorance and racism), which were at times very denigrating to her achievements as an Asian American woman.

We have seen from a young age that Lauren has always been a strong voice for the minority, and thus, it is no surprise that she has focused her legal career on practice areas that support and protect elders (e.g. - estate planning, probate and trust litigation, elder law, and her

largest client is Maui Memorial Medical Center filing their guardianships and conservatorships for incapacitated adults). She also continued to teach Business Law at UH Maui College for five academic years, almost as a calling, as there were very few Maui instructors and lecturers who looked like her and were born and raised on Maui. She received such positive feedback from her students, which kept her teaching despite her busy schedule.

It was natural for Lauren to become a per diem judge. She was unsure and worried about her ability to meet the rigorous academic needs of the job along with the weighty decisions that directly impact lives, but she jumped into the role and has been successful. We saw how she had to change her life to avoid conflicts of interest and rearrange her schedule to always be prepared for court, all while being a devoted mother to her sons. This took so much discipline with her time. As a judge, she has been able to moderate her decisions using evidence rather than beliefs or bias, and she has shown herself to be compassionate, empathetic, and respectful of the dignity of every person. She is undoubtedly open-minded and fair, almost to a fault, as sometimes she may be too frankly honest.

Additionally, she is neither ostentatious nor sets herself above anyone and has always tried to use rational judgment to create an opinion. She has the highest ethical values. Her integrity is beyond reproach, and she has the moral courage to continue her life's work of helping people in the face of any setbacks.

Personally, and professionally, the time during the Covid-19 pandemic brought many challenges for Lauren. She had to pivot in her solo practice as certain blocks of work stopped due in large part to the closure of the courts. She also saw the end of her 15-year marriage and her assault during a medical exam by a doctor on Oahu. Both were very difficult and painful experiences, but she never wavered in doing the right thing for her children, herself, and the community.

Lauren is truly a special person. We are biased as her parents, but for a Maui girl born and raised, there is no one like her. She is more than worthy of consideration to be appointed to the University of Hawaii Board of Regents.
