1) Why do you wish to be a member of the State Council on Mental Health?

RESPONSE: I began attending State Council on Mental Health meetings in December 2021 and was confirmed as a council member in July 2022. I have over 20 years of experience in the social services field working with and advocating for children and families, the disabled and elderly, and those with mental illness. Being a council member will allow me to continue advocacy in this area.

2) How do you perceive the role and responsibilities of a member of the State Council on Mental Health?

RESPONSE: I perceive the role and responsibilities of a member to be self-motivated in learning and identifying what mental health services are available in communities statewide, assisting the council in developing relationships with community advocates and leaders by providing a non-threatening space for the sharing of concerns and needs, and participating in constructive dialog aimed at ensuring mental health services are available and accessible in all communities.

3) Given your understanding of the roe and responsibilities of a member of the State Council on Menta Health, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the State Council Mental Health.

RESPONSE: I hold Master of Education and Bachelor of Social Sciences degrees with over 20 years of experience in the social services field working with and advocating for children and families, the disabled and elderly, and those with mental illness. As a social worker, I've advocated for children, parents, supporting family members who were in need of mental health and other support services. As a unit supervisor, I facilitated monthly meetings with community partners (mental health hospitals, mental health agencies, community support services agencies) to collaborate on developing plans that ensured the best chances of success in placing individuals with housing and mental health needs back into the community. As an Assistant Program Development Administrator, I work with federal grantee International Social Services (ISS) and the Administration For Children and Families via the Office of Human Services Emergency Preparedness and Response in relocating U.S. citizens who are experiencing financial, medical, and mental health issues in foreign countries. This involves collaborating with the Adult Protective Services (APS) Team in reviewing repatriation referral documents and determining the financial, medical, and mental health services these individuals will need for a successful transition to Hawaii. I believe this range of experience will continue to be beneficial to the council.

4) What do you hope to accomplish during your term of service?

RESPONSE: I hope to assist the council in its mission to "...advocate for a Hawaii where all persons affected by mental illness can access treatment and support necessary to live a full life in the community of their choice."

5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Council on Menta Heath?

RESPONSE:

Three qualities that describe me are respectful, engaged, and objective. Being objective in listening to individuals and advocates reporting the mental health needs of individuals and communities, with the willingness to engage and learn more about each, I believe is important in the process of developing respective relationships with the diverse communities in Hawaii. I believe these qualities would benefit the State Council on Mental Health.

6) Name one previous experience that would make you stand out. How would this benefit the State Council on Mental Health?

RESPONSE:

In a previous position, I facilitated a meeting with multiple community partners involving an operator of a community care home, mental health hospital staff (MH nurses, case workers, discharge personnel), a contracted community mental health agency, and a community support services agency. The goal was to assess resources in the community and develop a discharge plan that would be successful in resettling a chronically mentally ill individual back into community. This plan involved the creation of emergency response protocols by the MH agency, a time-limited exception-to-rate increase used by the care home operator to hire additional staff through the adjustment period, as well as case management services which involved monthly meetings with the MH client, the selected MH agency, the community support services agency, and the care home operator for case status updates. The plan was successful, and I believe this experience would benefit the State Council on Mental Health if similar topics of discussion arise.

7) Can you foresee any possible conflicts of interests that could arise during your service on the State Council on Mental Health? How would you overcome any possible conflicts of interest?

RESPONSE:

I foresee no conflicts of interests that could arise during my service on the State Council on Mental Health.

<u>**DEPARTMENT'S POSITION:**</u> the Department of Human Services (DHS) supports the nomination and confirmation of Samuel "Ray" Rice to the State Council on Mental Health (SCMH).

He will be an asset to have and will assist in improving the system of care that provides quality mental health services to the people of Hawaii.
