Aloha, Honorable Chair San Buenaventura,

Thank you for requesting more information regarding my nomination to the State Council on Mental Health (SCMH). Please find my responses as follows:

(1) Why do you wish to be a member of the State Council on Mental Health?

I have been honored to be an active member of the SCMH since July 1, 2022. I am seeking re-appointment to the Council per section 334-10(a)(1), HRS, representing a principal state agency with respect to vocational rehabilitation. Beyond that, I was born and raised in Hawaii, and the health, opportunity and security of our people are of utmost importance to me. I have spent my entire career working for the DHS Division of Vocational Rehabilitation, assisting those with disabilities, including psychiatric disabilities, by providing counseling, training, peer supports, higher education, reasonable accommodations, and other assistance, with the ultimate goals of self-sufficiency, empowerment, independent living, and competitive, integrated employment. My hope is to learn and share information with the other council members, as well as with the public, regarding the needs and capabilities of individuals with mental health disabilities in all areas of life, and particularly as related to employment.

(2) How do you perceive the role and responsibilities of a member of the State Council on Mental Health?

Per section 334-10(c), Hawaii Revised Statutes (HRS), the State Council on Mental Health (SCMH) advises the Department of Health on the allocation of resources, statewide needs, and programs affecting two or more service areas, reviews and comments on the statewide comprehensive integrated service plan, and advocates for adults with serious mental illness, children with serious emotional disturbances, other individuals with mental illnesses or emotional problems, and individuals with combined mental illness substance abuse disorders. Through monthly meetings, all members of the community are invited to share insights and concerns about the issues affecting mental health in the State.

I believe it is imperative that all Council members dedicate ourselves to hearing and addressing concerns from the public; review and advise on statewide mental health programs, resources and areas of need; advocate for the needs of individuals with mental health concerns and their families; and actively, regularly participate in all meetings of the Council.

(3) Given your understanding of the role and responsibilities of a member of the State Council on Mental health, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise or knowledge that would aid in your decision-making ability as a member of the State Council on Mental Health.

As mentioned in response (1) above, I have been employed by the DHS Division of Vocational Rehabilitation (DVR) as a counselor, supervisor and branch administrator for over 30 years and currently serve as the DVR Administrator. Throughout my career, I have counseled countless individuals with mental health disabilities as they work toward employment. I have had the opportunity to interface with various Department of Health programs and other mental health care provider with whom I have shared mutual consumers, including being assigned as the DVR liaison to the Koolau Clubhouse for a number of years.

I have a master's degree in education with a specialization in rehabilitation counseling from the University of Hawaii at Manoa. My experience as a counselor, and now a leader, in DVR has given me experience, skills, and knowledge in the importance of listening to others, communicating clearly, working cooperatively, analyzing the needs and strengths of programs, and making decisions which result in improvements for the constituents we serve.

(4) What do you hope to accomplish during your term of service?

In working together with the Council and listening to the concerns and needs of the public, I hope to be a part of improving mental health services for the people of Hawaii. I also hope to be a voice for the need for more training and employment opportunities for individuals with mental health disabilities.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Council on Mental Health?

- I am passionate about assisting individuals with disabilities, including those with significant mental health challenges, to overcome obstacles, recognize their strengths, and attain their career and life goals.
- I understand the importance of working together with others, including community members, in order to effectuate positive change.
- I am compassionate to the needs of our ohana nui and I work hard to help those in need.

I believe these qualities will benefit the SCMH as it is important for the Council to listen to the needs of individuals and families struggling with mental health concerns, and to work together to examine current programs' effectiveness in meeting those needs, including but not limited to opportunities for wellness and economic self-sufficiency.

(6) Name one previous experience that would make you stand out. How would this benefit the State Council on Mental Health?

I believe my experience in working as a counselor with individuals with psychiatric disabilities toward their career goals makes me stand out. This would benefit the SCMH by keeping the importance of employment and self-sufficiency opportunities on the table.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the State Council on Mental Health? How would you overcome any possible conflicts of interest?

If there is a vote to be made which could result in a conflict of interest as an employee of DHS/DVR, I would abstain from voting.

- the Council adopted the vision of a Hawai'i where people of all ages with mental health
- 3 challenges can enjoy recovery in the community of their choice. It adopted the mission to
- 4 advocate for a Hawai'i where all persons affected by mental illness can access necessary
- 5 treatment and support to live full lives in the community of their choice.
- 6 Ms. Dias fills the mandated Council membership position of a State agency employee
- 7 representing vocational rehabilitation under Chapter 334-10, Hawai'i Revised Statutes and
- 8 Federal Law, Public Law 102-321, Section 1914(c). She was recently promoted to be the
- 9 Department of Human Services Vocational Rehabilitation Administrator.
- Since her first appointment to the Council in 2022, Ms. Dias enthusiastically brought
- attention to vocational rehabilitation services that are helping many, including the mentally ill,
- 12 prepare for, find, and keep competitive employment. The attention increased interest,
- information exchange, and clarity about employment services and opportunities for the
- individuals that the SCMH advocates for. She provided leadership in regular statistical reports
- while offering insights into the person-centered nature of vocational rehabilitation services.
