(1) Why do you wish to be a member of the State Council on Mental Health?

To better understand how to meet the mental health needs of the Medicaid population in Hawaii.

(2) How do you perceive the role and responsibilities of a member of the State Council on Mental Health?

As an advocate for the needs and disparities of the citizens of Hawaii suffering from Mental Health (MH) disease. Additionally, I would also have an additional advocate 'hat' on for those in the Medicaid population suffering from MH disease.

Given your understanding of the role and responsibilities of a member of the State Council on Mental Health, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the State Council on Mental Health.

I have worked in healthcare in Hawaii all of the nearly 34 years of my professional career, and have a good understanding of the health care delivery system in Hawaii. Working for Medicaid for the past 18 years has given me an appreciation of the difficulties faced by Medicaid members who are experiencing mental health disease. At Medicaid, we have worked specifically to target policies that can service the continuum of care for mental health disease, understanding that what might work for the most acute members may not properly address the needs of less acute members. Finally, my past 3 year term as a member of the State Council on Mental Health has given me vital experience with leveraging the voice of the Council to advocate for those suffering with MH disease.

(4) What do you hope to accomplish during your term of service?

I hope to improve the lives of Hawaii residents who suffer from Mental Health disease. Additionally, I hope to fortify and strengthen the fragile (and sometimes broken) continuum of care for MH disease in the State of Hawaii.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Council on Mental Health?

Steady, good listener, collaborator. My steadiness will help moderate the decisions of the Board, so as to not lurch to assumptions or trends that may not be beneficial in the long term. I will listen to all constituencies and the experiences that they are struggling with, and will consider all voices as decisions are made. Collaborating with other Board members will facilitate complete communication and informed decision making.

(7) Name one previous experience that would make you stand out. How would this benefit the State Council on Mental Health?

Working as the Health Care Services Branch Administrator (HCSBA) for the Med-QUEST Division for the past 7+ years has exposed me to the many facets of Mental Health disease in the Medicaid population in Hawaii. From the difficulty of getting Applied Behavioral Analysis services to those who suffer from Autism Spectrum Disorder diagnoses; to the importance of taking a person-centered approach when designing a suite of services for our Intellectually/Developmentally Disabled population; to the extremely difficult conditions that case management agencies face when delivering services to the adults who suffer from Serious Mental Illness/Serious and Persistent Mental Illness; to finding permanent supportive housing placements through our Community Integration Services program for the Medicaid population suffering from houselessness because of their struggles with MH disease; my past 7+ years in the HCSBA position has shown me the many challenges and opportunities that are present in our current Mental Health delivery system.

(8) Can you foresee any possible conflicts of interests that could arise during your service on the State Council on Mental Health? How would you overcome any possible conflicts of interest?

I do foresee possible conflicts of interest, for instance in my past tenure when the Council voted on whether to support proposed legislation that is supported by the Hawaii Medicaid program. In these past instances where there was a potential conflict of interest, I have recused myself from voting on that specific issue piece of legislation. If it becomes necessary for me to step down because of a certain potential conflict of interest that cannot be avoided by a simple recusal, then I would gladly step down to avoid any impression of my conflict of interest tainting the Council's decisions.

- 14 comprehensive, integrated service plan. Collectively, it serves as an advocate for adults with
- 15 serious mental illness, children with serious emotional disturbances, other individuals with

mental illness or emotional problems, and individuals with combined mental illness and substance abuse disorder. In 2020, the Council adopted the vision of a Hawai'i where people of all ages with mental health challenges can enjoy recovery in the community of their choice. It adopted the mission to advocate for a Hawai'i where all persons affected by mental illness can access necessary treatment and support to live full lives in the community of their choice.

Mr. Fujii fills the mandated Council membership position of a State agency employee representing Medicaid and Chapter 334-10, Hawai'i Revised Statutes and Federal Law, Public Law 102-321, Section 1914(c). He is a member of the Hawai'i advisory commission on drug abuse and controlled substances ("HACDACS") and represents this commission on the Council. He is the Department of Human Services Med-QUEST Division Health Care Services Branch Administrator.

Since his first appointment in 2020, Mr. Fujii had the unique role of officially representing two areas: Medicaid and HACDACS. Last year, he patiently advocated for the mentally ill by explaining significant and dynamic changes in insurance program eligibility relating to the 2022 Congressional Act that decoupled Medicaid's continuous requirement from the COVID-19 public health emergency. Mr. Fujii continuously provided information resources and actions needed by QUEST members to stay insured, whether they remain eligible or must look elsewhere for health insurance coverage. He supported the alignment of efforts by sharing HACDACS planning and advocacy directions and actions on time. He also willingly shares his mana'o on Native Hawaiian worldview and perspectives when needed. Mr. Fujii is a thoughtful member of the Council and will continue to contribute to positive Council dynamics and results.

The Department respectfully requests your favorable consideration in confirming Mr. Fujii's appointment to the State Council on Mental Health.
