<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) supports the nomination and confirmation of Ms. Victoria "Vickie" Kennedy to the State Rehabilitation Council (SRC).

<u>PURPOSE</u>: The SRC was established by the Rehabilitation Act of 1973, as amended. The SRC works in partnership with the DHS Division of Vocational Rehabilitation (DVR) on services that address the employment needs of individuals with disabilities.

Ms. Kennedy is seeking her second term appointment to the SRC as a representative for Disability Advocacy Groups representing a cross-section of individuals with physical, cognitive, sensory, and mental disabilities, and parents, family members, guardians, advocates, or authorized representatives of individuals with disabilities who have difficulty in representing themselves or are unable due to their disabilities to represent themselves as described by section 348-8(a)(6), Hawaii Revised Statutes (HRS). Ms. Kennedy is also a person with a

disability, thus satisfying the requirement of section 348-8(a) that "a majority of the council members shall be persons who have disabilities and are not employed by the vocational rehabilitation division of the department."

Ms. Kennedy dedicated more than thirty years to advocating for individuals who are blind and visually impaired to live independently. Ms. Kennedy's first-hand experiences with blindness, educating the public on individuals who are blind or visually impaired, and her work for the legitimacy of service animals equip her with the knowledge that will make her a continued asset as a member of the SRC.
