I support Nancy Carr Smith's appointment to the State Land Use Commission. I have known Nancy for 18 years. For full disclosure, we have been married for 12+ years. We first met, when she chaired the Annual Pumpkin Patch, community event for the school that both of our children attended. She was the Committee Chair, I was a member of her group. She was very organized, was actively engaged and ran a successful event. Our relationship progressed, starting from that first time we met.

I know Nancy to be sincere, dedicated, hard-working and diligent in everything she sets her mind to do. She is a leader, has a strong moral and spiritual compass; she strives to do the right thing, make our community, island and State a better place, because she has contributed to it. She is not one to watch the parade go by; she is the type of person who will get involved, collaborate with others and make sound decisions, that are beneficial to her community.

## Most Importantly:

a. **Kuleana:** She has lived in Hawaii for over twenty years. She understands her community and our host culture. She was on the Board of Directors for Ka Ulu Lauhala o Kona, a weaving group. She was like a shadow to the group's matriarch, Aunty Elizabeth Maluihi Lee. She has worked with and learned from our kupuna, that taught her the art of lauhala weaving and more importantly teamwork, in getting things done. She understands that anything worth doing, is worth doing "right". She understands the art of compromise and that moving forward, while adhering to her principles is critical.

- b. Community Engagement: Nancy is not Hawaiian, she is Hawaiian at heart. She understands what local style is and has the ability to work with others to accomplish progress. As you can see from her resume, she strives to lead, take the right path forward. She is the current President of the Waimea Community Association, has chaired the Leeward Planning Commission, as well as the County Board of Appeals. She chairs the South Kohala First Responders Mahalo event, thanking those that have risked their lives to protect our community. She has also graduated from the Ulu Mau Leadership Series, that stresses Hawaiian values, in our modern world. If you want to find someone who can get things done, reach out to a busy person. They know how to manage their most valuable commodity, their time.
- c. **Negotiating Skills:** In Nancy's "day job", she regularly works with people who are investing their life savings, into their dream home. She needs to work with buyers and sellers and find the right balance between "what they want, what they need and what they can afford". She understands the importance of balance and compromise, in reaching an outcome, where everyone feels like they didn't get everything they wanted. That is the outcome of a fair negotiation, everyone is a "little unhappy".

## Other desirable attributes:

- a. **Consistent, reliable, shows up and is prepared;** Nancy knows that 90% of any commitment is "just showing up". She has been filling the Hawaii island role on the Land Use Commission, since July 2023. She has not missed one meeting, nor one Zoom call. She reads all the info ahead of meetings. If she has questions, she asks staff at the Commission, or those at the Office of Planning and Sustainable Development or the Attorney General's office for interpretation, clarification. She shows up "prepared".
- b. Knows what she knows, stays in her lane: It is an important trait to understand your own strengths, and more importantly your weaknesses. None of us know everything, all of us know something. Based on this understanding, she takes a strong position on topics that she is confident that she has the skill sets to understand, deliberate and vote on. Similarly, she will defer to others, if they are the subject matter expert on issues that she is not well-versed in.
