Chair Rhoads and Members of the Committee:

The Attorney General supports the reappointment of Blake Oshiro to the Commission to Promote Uniform Legislation (CPUL) of the Department of the Attorney General.

The CPUL is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of this state commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws, which is also referred to as the "Uniform Law Commission." The Uniform Law Commission requires that each appointed commissioner be a lawyer licensed to practice law and that members from each state attend and participate in its annual meeting.

Commissioner Oshiro is a lawyer licensed to practice law in Hawaii. He has experience with legislation from many perspectives. He served in the House of Representatives from November 2000 until November 2011, when he became Deputy Chief of Staff to Governor Abercrombie. He served in that role until December 2014, when he returned to the private practice of law. He then spent two years as the Executive Vice President of a consulting firm that specializes in government relations, including political advising and lobbying. He currently serves as a senior policy advisor

to Governor Green. Based on his varied legislative experiences, he is uniquely qualified to serve as a Commissioner of the CPUL.

Since his initial appointment in 2019, Commissioner Oshiro has attended and actively participated in the meetings of the CPUL. Each year since his appointment, he has assisted the CPUL advocate for the passage of Uniform Laws with lobbying efforts at the Legislature on bills that have been identified as priorities by the CPUL.

He has also attended the annual meetings of the Uniform Law Commission held in Anchorage, Alaska, from July 12-18, 2019; held online from July 10-15, 2020, via interactive conference technology; held in Madison, Wisconsin, from July 9-15, 2021, via interactive conference technology; and held in Honolulu, Hawaii, from July 21-26, 2023. Prior to and during the annual meetings of the Uniform Law Commission, the members from each state pool their resources to carefully draft uniform acts. During the annual meeting the members consider each draft act and in a careful, bipartisan effort, produce the impressive body of Uniform State Laws.

In his role with the Uniform Law Commission, Commissioner Oshiro served on the Public Meetings During Emergencies Drafting Committee in 2019-2021. From 2021 to September 2023, Commissioner Oshiro served on the Stakeholder Outreach Committee, which tasked him to participate in several different committees to monitor the need for any outreach to additional stakeholders for input or review. During the Uniform Law Commission 2023 annual meeting, he was designated as the Chair for the floor session of the committee of the whole when the Uniform Law Commission held its first reading of the Antitrust Pre-Merger Notification Act.

In view of his continuing participation in the activities of the Uniform Law Commission and of the CPUL, Blake Oshiro's continued service as a member of the CPUL and of the Uniform Law Commission will be beneficial to the State of Hawaii and the Uniform Law Commission. Consequently, the Attorney General respectfully requests that this Committee recommend the confirmation of the reappointment of Blake Oshiro to the CPUL.

Dear Chair Rhoads, Vice Chair Gabbard and Committee Members:

Thank you for hearing the confirmation of my re-appointment to the Commission to Promote Uniform Legislation (CPUL). The CPUL is housed within the Department of the Attorney General (AG) in an advisory capacity to the AG and to the Legislature to advise on uniform laws.

I was first appointed to the CPUL in 2019 and am seeking re-appointment to this position. My 5 years of service thus far have been educational, enlightening and productive. The Hawaii CPUL effectively supported and adopted or amended about a dozen acts during my time on the CPUL. As of 2023, Hawaii reported having 90 uniform laws in total.

The Uniform Law Commission was established in 1892 and provides states with non-partisan, well-conceived and well-drafted legislation that brings clarity and stability to critical areas of state statutory law. It also helps to ensure conformity and consistency for policies and laws across state lines, which can be critical for certain issues that have a higher likelihood of having parties and interests that cross multiple state jurisdictions.

It has been an honor to serve with intelligent and diligent legal professionals from various background and experiences, and it is a unique opportunity to hone legal and policy drafting and analysis though the thorough and sometimes lengthy process of the ULC.

Interestingly, the CPUL is one of the few commissions with express language the exempts appointments from the general limitation of two terms or a maximum duration of eight consecutive years. Haw. Rev. Stat. Section 26-7.
